- Candidates for the European Court of Human Rights (Rapporteur for opinion: Mr Mendes Bota, Portugal, EPP/CD): adopted the Committee's opinion;
- The code for good practices of the political parties (Rapporteur for opinion: Ms Bilgehan, Turkey, SOC): adopted the Committee's opinion (including amendments to be tabled on behalf of the Committee);
- State of human rights and democracy in Europe (Rapporteur for opinion: Ms Čurdová, Czech Republic, SOC): considered the amendments proposed by the Rapporteur, amended and approved them (for tabling on behalf of the Committee);
