The Committee on Equal Opportunities for Women and Men, meeting in Paris on 11 May 2007 with Ms Bilgehan (Turkey, SOC) in the Chair:

- The image of women in advertising (Rapporteur: Ms Bilgehan, Turkey, SOC) :
 - ✓ appointed Ms Bilgehan (Turkey, SOC) Rapporteur,
 - considered a draft report, amended and unanimously adopted a preliminary draft resolution and a preliminary draft recommendation with a view to presenting the report for debate at the June 2007 part-session;

- *Prostitution – which stance to take?* (Rapporteur: Mr Platvoet, Netherlands, UEL) : considered an introductory memorandum;

- *In favour of a Parliamentary Assembly "Equality Prize"* (Rapporteur: Mr Branger, France, EPP/CD) : *c*onsidered an introductory memorandum;
