## TO THE MEMBERS OF THE COMMITTEE ON EQUAL OPPORTUNITIES FOR WOMEN AND MEN

Secretariat of the Parliamentary Assembly Synopsis No. 2007/008 2 July 2007

**The Committee on Equal Opportunities for Women and Men**, meeting in Strasbourg on 25, 26 and 28 2007 with Ms Bilgehan (Turkey, SOC) and Ms Curdová (Czech Republic, SOC) in the Chair:

as regards:

- The image of women in advertising (Rapporteur: Mrs Bilgehan, Turkey, SOC): examined amendments proposed by the Rapporteur for tabling on behalf of the Commmittee, and took position on the amendments tabled to the draft resolution and the draft recommendation;

- The feminisation of poverty (Rapporteur: Ms Naghdalyan, Armenia, ALDE): took position on the amendments tabled to the draft resolution and the draft recommendation;

- National selection procedures for candidates for the European Court of Human Rights: instructed the Chairperson to ask the Bureau to propose to the Assembly that the Committee be seized for opinion on the issue;

- Blasphemy, religious insults and hate speech against persons on grounds of their religion (Rapporteur for opinion: Mr Dupraz, Switzerland, ALDE): adopted the Committee's opinion, including five amendments;

- In favour of a Parliamentary Assembly "Equality Prize" (Rapporteur: Mr Branger, France, EPP/CD): considered a revised introductory memorandum and decided to change the title of the report to: in favour of a Parliamentary Assembly "gender Equality Prize";

- *Prostitution – which stance to take?* (Rapporteur: Mr Platvoet, Netherlands, UEL): considered a draft report, amended and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report for debate at the Assembly October 2007 part-session;

- "Parliaments united in combating domestic violence against women": mid-term assessment (Rapporteur: Mr Mendes Bota, Portugal, EPP/CD):

 held an exchange of views on the follow-up to the decisions taken on 4 June 2007 at the second coordination meeting of the contact parliamentarians involved in the parliamentary dimension of the Council of Europe campaign to combat violence against women, including domestic violence (2006-2008);
