- Follow-up to Resolution 1635 (2008) and Recommendation 1847 (2008) on Combating violence against women: towards a Council of Europe convention:
 - heard a statement by the Chairperson
 - heard a statement by the Secretary General of the Council of Europe
 - held an exchange of views and agreed to launch a pan-European parliamentary initiative involving parliamentarians committed to combat violence against women on the occasion of the International Women's Day (8 March 2009).
- Action against sexist representations in the media (Rapporteur: Ms Stump, Switzerland, SOC): decided to modify the title of the report as follows: "Combating sexist stereotypes in the media" and held an exchange of views on the preparation of the hearing to be held in Paris on 24 March 2009;
- Appointment of rapporteurs: appointed the following rapporteurs:
 - ✓ Ms Circene (Latvia, EPP/CD) on *The rights of today's girls: the rights of tomorrow's women*;
 - Ms Kiuru (Finland, SOC) on *Involving women in the prevention and solution of unsolved conflicts in the Council of Europe area*;
 - ✓ Ms Qunitanilla (Spain, EPP/CD) on The real situation of rural women in Europe;

- Appointment of representatives to meetings organised by other bodies: appointed:
 - ✓ Ms Err (Luxembourg, SOC) to take part in the event on "the role of parliaments in promoting equal sharing of responsibilities between women and men" organised by the Inter-Parliamentary Union and the United Nations Division for the Advancement of Women on the occasion of the 53rd Session of the Commission on the Status of Women, New-York, 3-4 March 2009;
