Secretariat of the Parliamentary Assembly Synopsis No. 2009/02 27 March 2009

The Committee on Equal Opportunities for Women and Men, meeting in Paris, on 23 March 2009, with first Ms Circene (Latvia, EPP/CD), then Ms Čurdová (Czech Republic, SOC), and finally Mr Mendes Bota (Portugal, EPP/CD) in the Chair:

As regards:

- The rights of today's girls: the rights of tomorrow's women (Rapporteur: Ms Circene, Latvia, EPP/CD): considered a draft report and asked the Rapporteur to present a revised version to the Committee at its next meeting;
- *Migrant women: at particular risk of domestic* violence (Rapporteur: Ms Woldseth, Norway, EDG): considered an introductory memorandum and held an exchange of views with the following two experts:
 - ✓ Ms Stéphanie Condon, researcher, National Institute of Demographic Studies (INED),
 France
 - ✓ Ms Olga Trostiansky, Chairperson of the French branch of the European Women's Lobby;
- Cases of sexual violence against women in the east of the Democratic Republic of Congo (Rapporteur: Ms Smet, Belgium, EPP/CD): considered an outline report and decided to change the title to: "Sexual violence against women in armed conflict";
- "Marital rape" (Rapporteur: Ms Rupprecht, Germany, SOC): considered an introductory memorandum, held an exchange of views with Ms Kräuter-Stockton, public prosecutor (Germany) and member of the European Women Lawyers Association (EWLA), and decided to change the title to: "rape, including marital rape";
- The urgent need for action on so-called "honour crimes" (Rapporteur: Mr Austin, United Kingdom, SOC): considered an introductory memorandum;
- Implementation of Resolution 1635 (2008) on Combating violence against women: towards a Council of Europe convention: prepared the meeting of the contact parliamentarians on violence against women to be held in Istanbul (Turkey) on 15 May 2009;
