## TO THE MEMBERS OF THE COMMITTEE ON EQUAL OPPORTUNITIES FOR WOMEN AND MEN

Secretariat of the Parliamentary Assembly Synopsis No. 2010/05 29 June 2010

The Committee on Equal Opportunities for Women and Men, meeting in Strasbourg on 21 June 2010, with Ms Doris Stump (Switzerland, SOC), in the Chair:

As regards:

- *Islam, Islamism and Islamophobia in Europe* (Rapporteur for opinion: Ms Memecan, Turkey, ALDE): considered, amended and approved a draft opinion including 9 amendments to the report tabled by the Committee on Culture, Science and Education;

- *Combating sexist stereotypes in the media* (Rapporteur: Ms Stump, Switzerland, SOC): heard a statement by the rapporteur and decided to postpone this point to the meeting to be held on Thursday morning;

- *Fighting the global backlash against women's human rights* (Rapporteur: Ms Err, Luxembourg, SOC): heard a statement by the rapporteur and held an exchange of views;

**Resuming its meeting on 24 June 2010 at 8.30 am,** with Mr Mendes Bota (Portugal, EPP/CD), Chairperson, in the Chair:

- *Combating sexist stereotypes in the media* (Rapporteur: Ms Stump, Switzerland, SOC): heard a statement by the rapporteur and unanimously approved an amendment presented by the rapporteur;

Permanent Representations to the Council of Europe

- Implementation of Recommendation 1847 (2008) and Resolution 1635 (2008) on Combating violence against women: towards a Council of Europe convention:

- ✓ heard a statement from Mr Carlo Chiaromonte, Secretary of the CAHVIO;
- ✓ prepared the fifth meeting of the CAHVIO (Strasbourg, 29 June 2 July 2010) and adopted its position on the revised text of the future Convention;
- ✓ decided to organize a meeting of the network of contact parliamentarians committed to combat violence against women during the October part-Session with a view to launching a parliamentary pan-European initiative around 25 November 2010 (International Day on the elimination of violence against women) and proposed to convene a meeting of the Sub-Committee on violence against women on 10 September 2010 in Paris.

- Cooperation with the European Union: prepared the exchange of views of Mr Mendes Bota (Portugal, EPP/CD) with the Committee on Women's Rights and Gender Equality (FEMM) of the European Parliament, on 14 July 2010 and had an exchange of views on the subjects to be raised;

- *More women in economic and social decision-making bodies* (Rapporteur: Ms Gautier, France, EPP/CD): in the absence of the rapporteur, prepared the hearing to be held in Paris on Friday 10 September 2010;

**Resuming its meeting on 24 June 2010 at 2 pm,** with Mr Mendes Bota (Portugal, EPP/CD), Chairperson, in the Chair:

- *Combating sexist stereotypes in the media* (Rapporteur: Ms Stump, Switzerland, SOC): took position on four amendments;

- *Decent pensions for women* (Rapporteur: Ms Čurdová, Czech Republic, SOC): took position on two amendments tabled by the Social, Health and Family Affairs Committee;

- Appointment of rapporteurs: appointed the following rapporteurs for reports:
  - ✓ Ms Krista Kiuru (Finland, SOC) on European norms concerning the enforcement and supervision of restraining orders in case of gender-based violence;
  - ✓ Ms Elvira Kovács (Serbia, EPP/CD) on Action to combat violence against women must also take account of psychological violence;
  - ✓ Ms Doris Stump (Switzerland, SOC) on Sex-selective abortion "Gendercide".

And decided to postpone the appointment of a rapporteur for the following opinion:

- ✓ Request from the Parliament of Morocco for partner for democracy status within the Parliamentary Assembly (Rapporteur of the Political Affairs Committee: Mr Volontè, Italy, EPP/CD).
- Appointment of representatives to meetings organised by other bodies:
  - ✓ Mr José Mendes Bota (Portugal, EPP/CD) to take part in the Regional Workshop for Arab Parliaments on "Implementing CEDAW and ending violence against women", to be organised in Beirut on 27-29 July 2010 by the Economic and Social Commission for Western Asia (UN-ESCWA), the Inter-Parliamentary Union (IPU), the Lebanese Parliament and the United Nations Development Programme (UNDP) (subject to the authorisation of the Bureau);
  - ✓ Ms Carmen Quintanilla Barba (Spain, EPP/CD) to take part in the thematic debate on Partnerships among international organisations active in the field of trafficking in human beings: need for co-ordinated action in the framework of the 4th meeting of the Committee of the Parties to the CoE Convention on Action against Trafficking in Human Beings, Strasbourg, 13 September 2010.

- *Replies from the Committee of Ministers:* took note of the reply of the Committee of Ministers to the recommendation on "Rape of women, including marital rape";
