# Synopsis of the meeting held in Strasbourg from 1 to 4 October 2012

**The Committee on Equality and Non-Discrimination**, meeting in Strasbourg from 1 to 3 October 2012, with Ms Tina Acketoft (Sweden, ALDE) in the Chair

- on Monday 1 October 2012, as regards:
- For more democratic elections (Rapporteur for opinion: Ms Marietta de Pourbaix-Lundin, Sweden, EPP/CD): in the absence of the Rapporteur, approved a draft opinion to the report of the Committee on Political Affairs and Democracy, including three amendments;
- Gender equality and the reconciliation of family and professional life (Rapporteur: Ms Carmen Quintanilla Barba, Spain, EPP/CD): held an exchange of views on the basis of a memorandum;
- National developments: heard statements by:
  - Ms Bernadette Bourzai (France, SOC) on the adoption of new legislation on sexual harassment in France as well as the policy and legal measures taken by the French government to address the situation of Roma:
  - Ms Federica Mogherini Rebesani (Italy, SOC) on the recent signature of the Istanbul Convention by Italy;
- on Tuesday 2 October 2012, as regards:
- Political parties and women's political representation (Rapporteur: Ms Maria Stavrositu, Romania, EPP/CD): decided to table an oral amendment to the draft resolution and took note that no other amendments had been tabled:
- Criminalising the purchase of sex to combat the trafficking of people for sexual exploitation (Rapporteur: Mr José Mendes Bota, Portugal, EPP/CD): considered an outline for a report;
- Gender equality in South-East Europe (Rapporteur: Mr Jean-Charles Gardetto, Monaco, EPP/CD): heard a statement by the Rapporteur on his visit to Bosnia and Herzegovina (17-18 September 2012);
- Appointment of rapporteurs: appointed:
  - Mr Håkon Haugli (Norway, SOC) as Rapporteur for a report on Tackling discrimination on the grounds of sexual orientation and gender identity;

- Ms Tina Acketoft (Sweden, ALDE) as Rapporteur for a report on So-called "honour" crimes in North Caucasus;
- Mr Ferenc Kalmár (Hungary, EPP/CD) as Rapporteur for a report on The situation and rights of traditional national minorities in Europe;
- Mr Oleksiy Plotnikov (Ukraine, SOC) as Rapporteur for a report on Visa policy protection of public order or discrimination on the basis of nationality?

and heard from them a declaration on the absence of conflict of interest:

- Tackling intolerance and discrimination in Europe with a special focus on Christianity: took note
  of a motion which had been referred to it for information, heard a statement by Mr Valeriu Ghiletchi
  (Moldova, EPP/CD), first signatory of the motion and, following an exchange of views, decided to ask
  the Bureau to modify the reference with a view to being seized for report;
- Non-discrimination in access to justice: heard a statement by Ms Federica Mogherini Rebesani (Italy, SOC), and took note of a motion for a resolution;
- Composition of sub-committees: approved the following changes:
  - Ms Eleni Zaroulia (Greece, NR) joins the sub-committee on gender equality as a full member, and Ms Theodora Tzakri (Greece, SOC) as an alternate;
  - Ms Maria Giannakaki (Greece, NR) joins the sub-committee on the rights of minorities as a full member, and Ms Eleni Rapti (Greece, EPP/CD) as an alternate;
  - Ms Maria Giannakaki (Greece, NR) joins the sub-committee on racism and xenophobia as a full member, and Ms Theodora Tzakri (Greece, SOC) as an alternate;
- on Wednesday 3 October 2012, as regards:
- Tackling racism in law enforcement institutions (Rapporteur: Mr David Davies, United Kingdom, EDG): considered a revised outline for a report, took note of the Rapporteur's decision to limit the scope of the report to tackling racism in the police, and held a hearing with the participation of:
  - Ms Deborah Glass, Deputy Chair of the Independent Police Complaints Commission, United Kingdom;
  - Mr Julien Le Gars, Deputy Director for public liberties, Ministry of the Interior, France;
  - Ms Chantal Pons-Mesouaki, Deputy Secretary General of the Trade Union for public security officers, France;
  - Ms Lanna Hollo, Open Society Justice Initiative, France:

- Mr Boriss Cilevics (Latvia, SOC) to attend the launching of the Third Thematic Commentary on the Language Rights of Persons belonging to National Minorities, Strasbourg, 15 October 2012;

  - Strasbourg, during the 2013 1<sup>st</sup> part-session of the Assembly (21-25 January).
