## Synopsis of the meeting held in Strasbourg from 22 to 25 June 2015

**The Committee on Equality and Non-Discrimination**, meeting in Strasbourg from 22 to 25 June 2015, with Ms Gülsün Bilgehan (Turkey, SOC) in the Chair, as regards:

- on Monday 22 June, from 2 to 3 pm:
- Evaluation of the partnership for democracy in respect of the Parliament of Morocco (Rapporteur for opinion: Ms Sahiba Gafarova, Azerbaijan, EC / Rapporteur of the Committee on Political Affairs and Democracy: Mr Bogdan Klich, Poland, EPP/CD): approved a draft opinion to the report of the Committee on Political Affairs and Democracy, including four amendments;
- **Female genital mutilation in Europe** (Rapporteur: Ms Béatrice Fresko-Rolfo, Monaco, EPP/CD): heard a statement by the rapporteur and authorised her to conduct fact-finding missions to the Reproductive Health Institute (ISG) in Saint-Germain-en-Laye (France) and to the United Kingdom;
- **Composition of Sub-Committees**: approved the following changes in the composition of the Sub-Committee on Gender Equality:
  - Ms Maryvonne Blondin (France, SOC) became a full member ;
  - Ms Theodora Tzakri (Greece, UEL) became a full member and Ms Vasiliki Katrivanou (Greece, UEL) an alternate ;

- **Systematic collection of data on violence against women** (Rapporteur: Ms Maria Edera Spadoni, Italy, NR):

  - authorised the rapporteur to conduct a fact-finding visit to Finland,
  - hold a hearing with the participation of:

  - Ms Therese Murphy, Head of Operations, European Institute for Gender Equality (EIGE), Vilnius, Lithuania ;

  - Ms Sahiba Gafarova (Azerbaijan, EC) on her participation in the Parliamentary Seminar on the Istanbul Convention organised by the Parliamentary Network Women Free from Violence in Tbilisi, Georgia, on 16 June 2015,
