Synopsis of the meetings held in Strasbourg from 21 to 24 January 2008

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- on 21 January 2008 at 14 h, with Mr Eduard Kukan (Slovakia, EPP/CD), oldest member present, then Mr Pietro Marcenaro (Italy, SOC), in the Chair, as regards:
- **Election of the Bureau of the Committee**: elected Mrs Herta Däubler-Gmelin (Germany, SOC) Chairperson, Mr Pietro Marcenaro (Italy, SOC) 2nd Vice-Chairperson and Mrs Nino Nakashidzé (Georgia, ALDE) 3rd Vice-Chairperson, by acclamation;
