Synopsis of the meeting held in Paris on 2 June 2008

The Committee on Legal Affairs and Human Rights, meeting in Paris on 2 June 2008 with Mr Christos Pourgourides (Cyprus, EPP/CD), 1st Vice-Chairperson, and Mr Pietro Marcenaro (Italy, SOC), 2nd Vice-Chairperson, in the Chair, as regards:

- Gökçeada/Imbros and Bozcaada/Tenedos: preserving the bicultural character of the two Turkish islands as a model for cooperation between Turkey and Greece in the interest of the people concerned (Rapporteur: Mr Andreas Gross, Switzerland, SOC): considered and approved a report and adopted a draft resolution with a view to presenting them at the Assembly's June 2008 part-session;
- Implementation of judgments of the European Court of Human Rights (Rapporteur: Mr Christos Pourgourides, Cyprus, EPP/CD): considered and declassified an introductory memorandum and authorised the Rapporteur to request, in writing, additional information from the Chairpersons of the Assembly national delegations of the eleven countries where specific problems remain;
- Ratification by the Russian Federation of Protocol No 14 to the European Convention on Human Rights:
 - regretted the absence of Mr Pavel Krasheninnikov, Chairperson of the State Duma's Committee on Civil, Criminal, Arbitration and Procedural Legislation, with whom it was to hold an exchange of views;
 - debated the issue with the members of the Russian delegation; and
 - authorised the Chairperson of the Committee to go to Moscow in order to meet the members of the State Duma's Committee on Civil, Criminal, Arbitration and Procedural Legislation;
- Appointment of rapporteurs:
 - The need to avoid duplication of the work of the Council of Europe by the European Union Agency for Fundamental Rights: Mr Boris Cilevičs (Latvia, SOC)
 - Candidates for the European Court of Human Rights: Mrs Marie-Louise Bemelmans-Video (Netherlands, EPP/CD)
 - The protection of witnesses as a cornerstone for justice and reconciliation in the Balkans: Mr Jean-Charles Gardetto (Monaco, EPP/CD)
 - Women in prison (for opinion): Mrs Gultakin Hajiyeva (Azerbaijan, EPP/CD)
 - Private military and security firms and the erosion of the state monopoly on the use of force (for opinion): Mr Kimmo Sasi (Finland, EPP/CD)

- Freedom of religion and other human rights for non-Muslim minorities in Turkey and for Muslim minorities in Thrace (Western Greece) (Rapporteur: Mr Michel Hunault, France, EDG): heard a statement by the Rapporteur on his fact-finding visit to Turkey on 30-31 January 2008;
