of the meetings held in Strasbourg from 23 to 26 June 2008

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- on 23 June 2008 at 14 h with Mrs Herta Däubler-Gmelin (Germany, SOC) in the Chair, as regards:
- Freedom of religion and other human rights for non-Muslim minorities in Turkey and for Muslim minorities in Thrace (Western Greece) (Rapporteur: Mr Michel Hunault, France, EDG): heard a statement by the Rapporteur on his fact-finding visit to Greece on 16-19 June 2008 and held an exchange of views with the following experts:
 - Ms Asli Bilge, Lecturer at the University of Yeditepe (Istanbul) and Research Assistant at the CNRS Centre for Politics, Religion, Institutions, Society and Transformation in Europe (PRISME)
 - Mr Konstantinos Tsitselikis, Assistant Professor of Human Rights in the Department of Balkan, Slavic and Oriental Studies, University of Macedonia, Greece
 - Mr Alain Chablais, Executive Secretary *ad interim*, Framework Convention for the Protection of national minorities;
- Exchange of views with human rights defenders from the North Caucasus region: decided to hold this exchange of views on Wednesday 25 June 2008 at 14 h;
- **The death penalty in Council of Europe observer states**: heard a statement by Mrs Wohlwend (Liechtenstein, EPP/CD), announcing her intention to table a motion for a resolution/recommendation on this issue.

- carried out a **visit to the European Court of Human Rights.**

- Conference on specific challenges facing European democracies the case of diversity and migration and measures to improve the democratic participation of migrants (Strasbourg, 24 June 2008): appointed Mr Boriss Cilevičs (Latvia, SOC) to take part in this Conference;
- Candidates for the European Court of Human Rights (Rapporteur: Mrs Marie-Louise Bemelmans-Videc, Netherlands, EPP/CD): considered and approved a draft report and adopted a draft resolution, with a view to presenting them at the Assembly's 4th part-session of 2008;
- Investigation of crimes allegedly committed by high officials during the Kuchma rule in Ukraine (Rapporteur: Mrs Sabine Leutheusser-Schnarrenberger, Germany, ALDE): considered and approved a draft report and adopted a draft resolution and a draft recommendation, with a view to presenting them at a forthcoming session of the Assembly;
- Allegations of politically-motivated abuses of the criminal justice system in Council of Europe member states (Rapporteur: Mrs Sabine Leutheusser-Schnarrenberger, Germany, ALDE):
 - considered an introductory memorandum;
 - authorised to Rapporteur to carry out fact-finding visits to London, Paris, Berlin and Moscow;
 - decided to ask the Venice Commission to prepare an opinion on European standards as regards the independence of the judicial system;
- **Sub-Committee on Human Rights** (Chairperson: Mr Jean-Charles Gardetto, Monaco, EPP/CD): heard a report by the Chairperson of the Sub-Committee on the meeting held in Strasbourg on 24 June 2008, and endorsed the proposals of the Sub-Committee concerning the list of candidates to the European Committee for the Prevention of Torture (CPT) submitted by the parliamentary delegation of the Slovak Republic;
- The situation of human rights defenders in Council of Europe member states (Rapporteur: Mr Holger Haibach, Germany, EPP/CD): considered a supplementary introductory memorandum and decided to ask the Bureau to extend the mandate until 31 January 2009;
- **Situation in Cyprus:** decided to ask the Bureau to be seized for opinion on the report currently under preparation in the Political Affairs Committee.

- on 25 June 2008 at 14 h with Mr Christos Pourgourides (Cyprus, EPP/CD), 1st Vice-Chairperson, in the Chair, as regards:
- Exchange of views with human rights defenders from the North Caucasus region: held an exchange of views with the participation of:

- Legal remedies for human rights violations in the North-Caucasus Region (Rapporteur: Mr Dick Marty, Switzerland, ALDE): confirmed the Rapporteur's appointment and authorised him to carry out a fact-finding visit to the region;

 - Inhumane treatment of people and illicit trafficking in human organs in Kosovo: Mr Dick Marty (Switzerland, ALDE)
 - Draft Council of Europe Convention on Access to Official Documents: Mr Klaas de Vries (Netherlands, SOC);

- **Motion for a resolution: "Secret detention centres: clarifying the allegations":** following a request for an opinion from the Bureau on the possible follow-up to be given to this motion, decided not to request to be seized of the motion contained in Doc 11398, since clarifications were not necessary, and asked its Chairperson to inform the Bureau accordingly;
