## **Synopsis**of the meetings held in Paris on 9 September 2008

**The Committee on Legal Affairs and Human Rights,** meeting in Paris on 9 September 2008 with Mrs Herta Däubler-Gmelin (Germany, SOC), in the Chair, as regards:

- **Draft Council of Europe Convention on Access to Official Documents** (Rapporteur: Mr Klaas de Vries, Netherlands, SOC): considered and approved a report and adopted a draft opinion, with a view to presenting them at the Assembly's September/October 2008 part-session;

with Mr Christos Pourgourides (Cyprus, EPP/CD), 1<sup>st</sup> Vice-Chairperson, in the Chair (only as regards the next item):

- Co-operation with the International Criminal Court (ICC) and its universality (Rapporteur: Mrs Herta Däubler-Gmelin, Germany, SOC): considered and approved a report and adopted a draft resolution:
- Protection of human rights in emergency situations (Rapporteur: Mr Holger Haibach, Germany, EPP/CD): considered an introductory memorandum and held a hearing with the participation of the following experts:
  - Ms Finola Flanagan, member of the European Commission for Democracy through Law ("Venice Commission") and Director General, Office of the Attorney General, Dublin
  - Ms Kirsten Mlacak, Head of the Human Rights department, Office for Democratic Institutions and Human Rights (ODIHR), OSCE, Warsaw
  - Ms Anya Tsitsina, Europe Programme Assistant, International Crisis Group (ICG), Brussels
  - Mr Avetik Ishkhanyan, Chairman of the Helsinki Committee in Armenia, Yerevan

## Appointment of rapporteurs:

- Compliance with the International Court of Justice decision in the Avena case: Mrs Renate Wohlwend (Liechtenstein, EPP/CD)
- Proposed 42-day pre-charge detention in the United Kingdom: Mr Klaas de Vries (Netherlands, EPP/CD)
- Situation in Cyprus (for opinion): Mr Boriss Cilevičs (Latvia, SOC)
- Consequences of the war between Georgia and Russia (for opinion) [subject to the ratification by the Parliamentary Assembly of the proposed debate under urgent procedure and of the references proposed by the Bureau]: Mr Christos Pourgourides (Cyprus, EPP/CD);
- Motion for a recommendation on the obligation of member states of the Council of Europe to co-operate in prosecution of war crimes: decided to ask the Bureau to be seized for report on this issue;

- Replies from the Committee of Ministers to recommendations emanating from the Committee: took note of the following replies:
  - The concept of "nation" (Rapporteur: Mr György Frunda, Romania, EPP/CD)
  - Towards decriminalisation of defamation (Rapporteur: Mr Jaume Bartumeu Cassany, Andorra, SOC)
  - State of human rights and democracy in Europe (Rapporteur: Mr Christos Pourgourides, Cyprus, EPP/CD
  - United Nations Security Council and European Union blacklists (Rapporteur: Mr Dick Marty, Switzerland, ALDE)
  - Video surveillance of public areas (Rapporteur: Mr Yuri Sharandin, Russian Federation, EDG)
  - Draft Convention of the Council of Europe on the adoption of children (revised) (Rapporteur: Mr Jaume Bartumeu Cassany, Andorra, SOC)

and, having observed that too many replies were unsatisfactory, asked its Chairperson to raise the question of follow-up by the Committee of Ministers to Assembly recommendations at the next meeting of the Bureau of the Assembly with a view to putting it on the agenda of a forthcoming meeting of the Joint Committee;

- Nomination of candidates and election of judges to the European Court of Human Rights (Rapporteur: Mr Christopher Chope, United Kingdom, EDG): considered a preliminary draft report, declassified it and decided to ask the Bureau to extend the mandate until 31 December 2008;
- The situation of Roma in Europe and relevant activities of the Council of Europe (Rapporteur: Mr József Berényi, Slovak Republic, EPP/CD): considered an introductory memorandum and declassified it;
- Minority protection in Europe: best practices and deficiencies in implementation of common standards (Rapporteur: M. Boriss Cilevičs, Latvia, SOC): heard a statement by the Rapporteur on his information visit to Austria and the Slovak Republic from 9 to 11 June 2008;
- Death of Magomed Yevloyev: approved a public statement;
- Discrimination on the basis of sexual orientation and gender identity (Rapporteur: Mr Andreas Gross, Switzerland, SOC): authorised the Rapporteur to carry out an fact-finding visit to Lithuania on the occasion of his visit to Poland (already authorised) and to carry out a fact-finding visit to Moldova;
- The Russian Federation's non-ratification of Protocol No 14 to the European Convention on Human Rights: took note of a memorandum prepared by the Secretariat upon the instructions of the Chairperson and was informed that the Chairperson would visit Moscow on 10-11 October 2008;
- Appointment of representatives of the Committee:
  - Conference "International Courts and Tribunals the Challenges ahead" (London, 6-7 October 2008): Mrs Herta Däubler-Gmelin (Germany, SOC);
- Participation of members in conferences, meetings, seminars, etc.: heard a report by the following representative:
  - European Commission for Democracy through Law ("Venice Commission") (Venice, 13-14 June 2008): Mr Christos Pourgourides (Cyprus, EPP/CD)
- Membership of sub-committees:
  - Sub-Committee on Human Rights: Mr Hugo Vandenberghe (Belgium, EPP/CD) to become a member, with Mr Philippe Monfils (Belgium, ALDE) as his alternate
  - Sub-Committee on Crime Problems and the Fight against Terrorism: Mr Hugo Vandenberghe (Belgium, EPP/CD) to become a member, with Mr André Flahaut (Belgium, SOC) as his alternate;

- Next meetings:
  - Strasbourg, during the Assembly's 4<sup>th</sup> part-session of 2008 (29 September 3 October)
  - Moscow (Russian Federation), Monday 10 and Tuesday 11 November 2008
  - Paris, Thursday 11 December 2008 at 9 h (Council of Europe Office)
  - Strasbourg, during the Assembly's 1<sup>st</sup> part-session of 2009 (26 30 January)
