## To the Members of the Committee on Legal Affairs and Human Rights

## **Synopsis**

of the meetings held in Strasbourg from 28 September to 1 October 2009

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- on 29 September 2009 at 14 h, with Mr Pietro Marcenaro (Italy, SOC), 2<sup>nd</sup> Vice-Chairperson, then Mr Christos Pourgourides (Cyprus, EPP/CD), 1<sup>st</sup> Vice-Chairperson, in the Chair, as regards:
- Drafting an additional Protocol to the European Convention on Human Rights concerning the right to a healthy environment (Rapporteur: Mr Christopher Chope, United Kingdom, EDG): considered a report tabled by the Committee on the Environment, Agriculture and Local and Regional Affairs and approved an opinion and five amendments to the draft recommendation;
- Consideration of a motion for a resolution on the definition of political prisoners sent to the Committee for consultation on possible follow-up: decided to recommend to the Bureau that this motion be sent to the Committee for report;
- Sub-Committee on Human Rights (Chairperson: Mr Jean-Charles Gardetto, Monaco, EPP/CD): heard a report by the Vice-Chairperson of the Sub-Committee, Mrs Marie-Louise Bemelmans-Videc, on the meeting held in Strasbourg on 29 September 2009 and endorsed the proposals of the Sub-Committee concerning the lists of candidates to the European Committee for the Prevention of Torture (CPT) submitted by the parliamentary delegations of the United Kingdom, Austria, Serbia, Turkey, Luxembourg, Slovenia, Germany and Bulgaria;
- Sub-Committee on the Election of Judges to the European Court of Human Rights (Chairperson: Mr Boriss Cilevičs, Latvia, SOC): heard a report by the Chairperson of the Sub-Committee on the meeting held in Strasbourg on 28 September 2009.

- on 30 September 2009 at 14 h, with Mr Christos Pourgourides in the Chair, as regards:
- Allegations of politically-motivated abuses of the criminal justice system in Council of Europe member states (Rapporteur: Mrs Sabine Leutheusser-Schnarrenberger, Germany, ALDE): took position on the amendments to the draft resolution;
- Legal Remedies for Human Rights violations in the North Caucasus region (Rapporteur: Mr Dick Marty, Switzerland, ALDE): considered and declassified a second information report (AS/Jur (2009) 43);

- The protection of witnesses as a cornerstone for justice and reconciliation in the Balkans (Rapporteur: Mr Jean-Charles Gardetto, Monaco, EPP/CD): considered an introductory memorandum;
- An internationally recognised status of election observers (Rapporteur: Mr Frans Weekers, Netherlands, ALDE): decided to ask the Bureau to extend the mandate until 30 June 2010;
- The European Charter for Regional or Minority Languages (Rapporteur: Mr József Berényi, Slovak Republic, EPP/CD): decided to ask the Bureau to extend the mandate until 30 June 2010;
- "Parliamentary scrutiny of standards of the ECHR": decided to hold a hearing on this issue in Paris on 16 November 2009, with the participation of experts, in the context of the Conference on the future of the European Convention on Human Rights, to take place in Interlaken (Switzerland) in February 2010;
- The necessity to take additional international legal steps to deal with sea piracy (Rapporteur: Mr Serhiy Holovaty, Ukraine, ALDE): authorised the rapporteur to attend the meeting of the Political Affairs Committee in Brussels on 17 November 2009, and to be accompanied by an expert;
- **Situation in Belarus:** decided to ask the Bureau to be seized for opinion on the report to be prepared by the Political Affairs Committee;
- **Membership of sub-committees**: took note of the following changes:
  - Mr Joseph Fenech Adami (Malta, EPP/CD) to become a member of the Sub-Committee on Human Rights, with Mrs Marie-Louise Coleiro-Preca as alternate
  - Mr René Rouquet (France, SOC) to become a member of the Sub-Committee on the Rights of Minorities
  - Mrs Zaruhi Postanjan (Armenia, EPP/CD) to become a member of the Sub-Committee on Crime Problems and the Fight against Terrorism
  - Mr Krasimir Minchev (Bulgaria, EPP/CD) to become a member of the Sub-Committee on Crime Problems and the Fight against Terrorism

  - Mr Jeremy McBride, Barrister, Visiting Professor, Central European University, Budapest and Member of the Scientific Committee of the European Union's Fundamental Rights Agency, Vienna
  - Mr David Anderson, QC, Brick Court Chambers, Visiting Professor of Law, King's College London
