Synopsis of the meeting held in Tbilisi (Georgia) on 16-17 September 2010

The Committee on Legal Affairs and Human Rights, meeting in Tbilisi with Mr Christos Pourgourides (Cyprus, EPP/CD), in the Chair, as regards:

- Non-participation of members of the Russian delegation: was informed by the chairman of the non-participation of members of the Russian delegation following the decision of the Georgian authorities not to issue a visa for one of the members of that delegation and noted his intention to raise the matter at the next meeting of the Bureau;
- Topical legal issues in Georgia: held an exchange of views with the participation of:
 - Mr Avtandil Demetrashvili, Chairman of the State Constitutional Commission of Georgia
 - Mr Pavle Kublashvili, Chairman of the Committee on Legal Issues of the Parliament of Georgia
 - Ms Eka Popkhadze, Georgian Young Lawyers Association
- Cooperation with the European Parliament: held an exchange of views with Ms Heidi Hautala, Chairperson of the Subcommittee on Human Rights of the Foreign Affairs Committee, European Parliament, on a number of issues of mutual interest;
- The death penalty in Council of Europe member and observer countries an unacceptable violation of human rights (Rapporteur: Mrs Renate Wohlwend, Liechtenstein, EPP/CD): considered and approved a draft report and adopted a draft resolution;
- Human rights and business (Rapporteur: Mr Holger Haibach, Germany, EPP/CD): in the absence of the rapporteur, considered and approved a draft report and adopted a draft resolution and a draft recommendation;
- The need for a global consideration of human rights implications of biometrics (Rapporteur: Mr Holger Haibach, Germany, EPP/CD): in the absence of the rapporteur, considered an introductory memorandum and decided to ask the Bureau for an extension of the mandate until 31 December 2010;
- The obligation of member states of the Council of Europe to co-operate in prosecution of war crimes (Rapporteur: Mr Miljenko Dorić, Croatia, ALDE): considered and approved a draft report and adopted a draft resolution and a draft recommendation;

- Abuse of state secrecy and national security: obstacles to parliamentary and judicial scrutiny of human rights violations (Rapporteur: Mr Dick Marty, Switzerland, ALDE): held a hearing with the participation of:
 - Mr Armando Spataro, Deputy Chief Public Prosecutor, Milan (Italy)
 - Mr Ian Leigh, Professor of Law, Durham University (United Kingdom)
 - Mr Adam Bodnar, Secretary General of the Polish Human Rights Helsinki Foundation
