# Synopsis of the meeting held in Strasbourg from 3-6 October 2011

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- **on Monday 3 October 2011 at 2pm**, with Mr Christos Pourgourides in the Chair, (Cyprus, EPP/CD), as regards:
- Request for Partner for Democracy status with the Parliamentary Assembly submitted by the Palestinian National Council (Rapporteur: Ms Özlem Türköne, EPP/CD): considered and unanimously approved the Committee's opinion and agreed to the presentation of the opinion in the debate by the Chair, following the departure of Mrs Türköne from the Assembly;
- The impact of the Lisbon Treaty on the Council of Europe (Rapporteur: Mr Peter Omtzigt, Netherlands, EPP/CD): considered and unanimously approved the Committee's opinion;
- **Declassification of information memorandum:** at the request of Mrs Marieluise Beck (Germany, ALDE), agreed to declassify her information memorandum on the case of Sergey Magnitsky;
- Fact-finding mission: agreed to a fact-finding mission to Kyiv, Ukraine, requested by Mrs Marieluise Beck (Germany, ALDE), in the context of her report on "Threats to the Rule of Law in Council of Europe member states: asserting the Parliamentary Assembly's authority";
- The situation of Roma in Bulgaria: adopted a statement proposed by Mr Boriss Cilevičs (Latvia, SOC), calling for the Bulgarian authorities to protect Roma in the current wave of acts of anti-Gypsyism in Bulgaria;
- Access to nationality (Rapporteur: Mr Boriss Cilevičs, Latvia, SOC): held an exchange of views on an introductory memorandum;
  - on Tuesday 4 October 2011 at 8.30am,
- National sovereignty and statehood in contemporary international law: the need for clarification (Rapporteur: Ms Marina Schuster, Germany, ADLE): took position on the amendments to the draft resolution;

- . Strengthening the institution of ombudsman in Europe: appointed Mr Jordi Xuclà I Costa, (Spain, ALDE),
- . Situation in Belarus (for opinion): appointed Mrs Marieluise Beck (Germany, ALDE);
- The inadmissibility of restrictions on freedom of movement as punishment for political positions (Rapporteur: Mr Tuğrul Türkes, Turkey, EDG): held an exchange of views with Ms Nuala Mole, Director of the AIRE (Advice on Individual Rights in Europe) Centre, London, United Kingdom;

#### on Wednesday 5 October 2011 at 2pm

- Combating all forms of discrimination and intolerance based on religion (Rapporteur: Mr Tudor Panţiru, Romania, SOC): considered and approved a draft report and unanimously adopted a draft resolution and a draft recommendation and agreed to the Rapporteur's proposal to change the title to "Combating all forms of discrimination based on religion";
- Sub-Committee on Human Rights: heard a report by the Vice-Chair, Mr Arcadio Diaz Tejera (Spain, SOC) regarding the Sub-Committee's meeting held in Strasbourg on 4 October 2011 and endorsed the proposals of the Sub-Committee concerning the lists of candidates to the European Committee for the Prevention of Torture (CPT) submitted by the parliamentary delegations of Andorra, Cyprus, Italy, Albania, Romania, Armenia, Ireland, Iceland, San Marino, Serbia and a draft statement submitted by the Sub-Committee on Human Rights on the case of the Belarusian human rights defender, Ales Bialiatski;
- Motion sent to the Committee for consultation on possible follow-up "Criteria for the definition of a political prisoner": agreed to request the Bureau to send this motion to the Committee "for information";

### Other business:

• **Azerbaijan:** agreed to a change of title of the report of Mr Strässer (Germany, SOC) from "Definition of political prisoners / Follow-up to the issue of political prisoners in Azerbaijan" to "Revisiting the issue of political prisoners";

- . agreed to the participation of Mrs Bemelmans-Videc in a forthcoming conference on "2020 vision for the European Court of Human Rights", 17-19 November 2011, Wilton Park, United Kingdom, subject to the availability of funds;
- agreed to the participation of Mr Jordi Xuclà I Costa, (Spain, ALDE), Rapporteur for "Strengthening the institution of ombudsman in Europe" to attend a seminar on the "The defense of rights and good practices in private management of public services. The role of the ombudsman", on 21-22 November 2011 in Barcelona, Spain, subject to the availability of funds;
- agreed to the participation of Mrs Mailis Reps (Estonia, ALDE), to attend the "Round table on Human Rights Defenders in the Council of Europe area" to be held in Strasbourg on 27-28 October 2011, at no cost to the Parliamentary Assembly;
