Synopsis of the meeting held in Strasbourg from 24 to 26 April 2012

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- On Tuesday 24 April 2012 at 8.30, with Mr Christopher Chope (United Kingdom, EDG), in the Chair, as regards:
- Keeping political and criminal responsibility separate (Rapporteur: Mr Peter Omtzigt, Netherlands, EPP/CD): considered an introductory memorandum presented by the Chair in the absence of Mr Omtzigt; decided to request an Opinion from the Venice Commission on the constitutional aspects of this issue and authorised the Rapporteur to launch an ECPRD request to obtain information on relevant legislation in member states, and to hold a hearing with two legal experts at its meeting on 21 May 2012;
- The accession of non-member states to the Council of Europe conventions (Rapporteur: Mr Rafael Huseynov, Azerbaijan, ALDE): considered an introductory memorandum and agreed to a change of title to "The participation of non-member states in Council of Europe conventions" and authorised a hearing with experts at a forthcoming meeting;
- **World Forum for Democracy** (5-11 October 2012, Strasbourg):nominated the following members to take part in the Ad hoc Committee of the Bureau to participate in the Forum:

Mr Mevlüt Çavuşğlu (Turkey, EDG) Mr Tamás Gaudi Nagy (Hungary, NR) Mr Rafael Huseynov (Azerbaijan, ALDE) Ms Elena Nikolaeva (Russian Federation, EDG) Mr Jordi Xucla (Spain, ALDE)

- High Level Conference on the future of the European Court of Human Rights, Brighton, 18-20 April 2012: heard a statement by the secretariat on the salient points drawn from the High Level Conference at Brighton;
- on Tuesday 24 April 2012 at 2pm as regards:
- Replies from the Committee of Ministers to recommendations emanating from the Committee: took note of the replies to the following recommendations: "The necessity to take additional international legal steps to deal with sea piracy", "Reinforcing the effectiveness of Council of Europe treaty law", "The need for a global consideration of the human rights implications of biometrics" and "Strengthening torture prevention mechanisms in Europe";

- Measures to improve the democratic character of elections in Council of Europe member states (reappointment of a Rapporteur, for Opinion, following the departure of the previous Rapporteur, Mr Markov (Russian Federation, EDG), from the Assembly): appointed Mr Michael McNamara, (Ireland, SOC);
- **Revisiting the issue of political prisoners:** took note of the information provided by the Chairperson on the lack of agreement between the Rapporteur and the head of the Azerbaijani delegation about the scope of the fact-finding visit to Azerbaijan planned for the first week of May 2012 and took note that the Rapporteur would present his report for adoption at the committee meeting during the June 2012
 - part-session without having to visit Baku;
- Hearing: Implementation of Strasbourg Court judgments by Italy: hearing held in the context of two reports "Implementation of judgments of the European Court of Human Rights" (Rapporteur: Mr Klaas de Vries, Netherlands, SOC) and "Ensuring the viability of the Strasbourg Court: structural deficiences in States Parties" (Rapporteur: Mr Serhii Kivalov, Ukraine, EDG): held a hearing with head of the Italian delegation, Mr Luigi Vitali;
- on Thursday 26 April 2012 at 8.30am, as regards:
- Exchange of views with Mr Nils Muižnieks, Council of Europe Commissioner for Human Rights: heard a statement by the new Commissioner on the main issues he wishes to focus on during the course of his mandate and held an exchange of views with him on that subject;

- extension of the validity of the reference regarding "Threats to the Rule of Law in the Council of Europe member states: asserting the Parliamentary Assembly's authority": agreed to request an extension from the Bureau until 30 June 2013;
- confirmation of Rapporteurships: following the Bureau's decision to end permanent rapporteurships, confirmed Mr Klaas de Vries (Netherlands, SOC) as the current Rapporteur for "Implementation of judgments of the European Court of Human Rights" and Ms Mailis Reps (Estonia, ALDE) as the current Rapporteur for "The situation of human rights defenders in Council of Europe member states";
- Conference on Security and Right to Information, Copenhagen, end September 2012: agreed to the participation of Mr Arcadio Díaz Tejera (Spain, SOC), subject to the availability of funds;
- Seminar on Constitutional Design Venice Commission Helsinki 21-22 May 2012: agreed to the participation of Mr Serhiy Holovaty (Ukraine, ALDE), subject to the availability of funds;
