## To the members of the Committee on Legal Affairs and Human Rights

## Synopsis of the meetings held in Strasbourg from 30 September to 3 October 2013

**The Committee on Legal Affairs and Human Rights,** meeting in Strasbourg from 30 September to 3 October 2013:

- **on Monday 30 September 2013 at 2pm,** with Mr Christopher Chope (United Kingdom, EDG), in the Chair, took note of the lack of quorum, closed the meeting and opened a new one;
- The European Union and Council of Europe human rights agendas: synergies not duplication!: following the transmission by the Bureau of a reference for urgent debate on this subject, appointed Mr Michael McNamara (Ireland, SOC) as rapporteur;
- Administrative detention (Rapporteur: Mr Agustín Conde, Spain, EPP/CD): considered an introductory memorandum and took note of the Rapporteur's intention to present a revised version of his memorandum at the Committee's December 2013 meeting;

Other business:

- World Forum on Democracy (Strasbourg, 27-29 November 2013): appointed members to the ad hoc Committee of the Bureau to participate in this event; Ms Elena Centemaro (Italy, NR), Mr Rafael Huseynov (Azerbaijan, ALDE), Mr Charles Kennedy (United Kingdom, ALDE), Mr Epameinondas Marias (Greece, EDG), Ms Milica Marković (Bosnia and Herzegovina, SOC), Mr Michele Nicoletti (Italy, NR) and Mr Konstantynos Triantafyllos (Greece, SOC);
- Sub-Committee on the Election of Judges to the European Court of Human Rights: took note of the Sub-Committee's report of its meeting held on 29 September 2013 in Strasbourg;
- Resolution 1943 (2013): Corruption as a threat to the Rule of Law, Proposal regarding the implementation of paragraph 13 of the Resolution: invited the Secretariat to contact the Assembly's Parliamentary Project Support Division as well as the Secretariat of the Committee on Rules of Procedure, Immunities and Institutional Affairs regarding the possible organisation of seminars or workshops on this subject and to report back to the Committee at a subsequent meeting;
- Motion transmitted for information: Prosecution of the Labour Party (Darbo Partija) in Lithuania: heard a statement by the leader of the Lithuanian Labour Party, Mr Vytautas Gapsys, and invited its Chair to raise the question of possible follow-up to the motion in the Bureau;
- Implementation of judgments of the European Court of Human Rights (*Rapporteur: Mr Klaas de Vries, Netherlands, SOC*): authorised the Rapporteur to carry out fact-finding visits to Italy, the Russian Federation, Turkey and Ukraine and, if need be, also to Poland and Romania, and agreed to request an extension of the reference until 31 December 2014;

- **on Tuesday 1 October 2013 at 2pm,** with Mr Christopher Chope (United Kingdom, EDG), in the Chair, as regards:
- National Security and access to information (Rapporteur: Mr Arcadio Díaz Tejera, Spain, SOC): Considered and took position on eleven amendments to the draft resolution;
- The European Union and Council of Europe human rights agendas: synergies not duplication! (Rapporteur: Mr Michael McNamara, Ireland, SOC): considered a draft report and adopted a draft resolution;
- Access to nationality and the effective implementation of the European Convention on Nationality (ETS No. 112) (Rapporteur: Mr Boriss Cilevičs, Latvia, SOC): considered a draft report, and adopted a draft resolution and a draft recommendation;
- Appointment of rapporteurs:
  - Request for an opinion from the Committee of Ministers, Draft Council of Europe Convention against Trafficking in Human Organs for opinion: appointed Mr Valeriu GHILETCHI (Republic of Moldova, EPP/CD);
