Synopsis of the meeting held in Paris on 12 December 2013

The Committee on Legal Affairs and Human Rights, meeting in Paris on 12 December 2013 with Mr Christopher Chope (*United Kingdom, EDG*) in the Chair, as regards:

- Revision of the European Convention on transfrontier television (Rapporteur: Mr James Clappison, United Kingdom, EDG): considered a draft report and unanimously adopted a draft resolution and a draft recommendation;
- The European Convention on Human Rights: reinforcement and consolidation of the training of judges, law enforcement officials and lawyers (Rapporteur: Mr Jean-Pierre Michel, France, SOC): in the absence of the Rapporteur, decided to postpone consideration of a draft report until the January 2014 part-session;
- Administrative detention (Rapporteur: Mr Agustín Conde, Spain, EPP/CD): considered a revised introductory memorandum and agreed to hold a hearing with experts at a future meeting (subject to the availability of funds);
- Urgent need to deal with new failures to co-operate with the European Court of Human Rights
 (Rapporteur: Mr Kimmo Sasi, Finland, EPP/CD): considered a draft report and unanimously adopted a
 draft resolution and a draft recommendation;

Measures to prevent abusive use of the Convention on the Transfer of Sentenced Persons (ETS No. 112) (Rapporteur: Mr Christopher Chope, United Kingdom, EDG): considered an introductory memorandum and held an exchange of views with Mr Eugenio Selvaggi, Deputy Prosecutor General at the Court of Cassation, Rome;

(with Mr Christopher Chope (United Kingdom, EDG) in the Chair)

The situation of fundamental rights in the European Union: held and exchange of views with Ms Kinga Göncz, Vice-Chair of the Committee on Civil Liberties, Justice and Home Affairs (LIBE) of the European Parliament. Following an incident involving Mr Tamás Gaudi Nagy (Hungary, NR), agreed to a proposal by the Chair to request the President of the Assembly to take disciplinary action;

Appointment of rapporteurs

- i. Access to justice through online instruments appointed, Mr Jordi Xuclà, Spain, ALDE;
- ii. Drones and targeted killings: the need to uphold human rights (Re-appointment owing to the imminent departure of Ms Marina Schuster, Germany, ALDE, from the Assembly) – appointed Mr Arcadio Díaz Tejera, Spain, SOC;
- iii. Evaluation of the partnership for democracy with the Palestinian National Council (for opinion) (Reappointment owing to the imminent departure of Ms Marina Schuster, Germany, ALDE, from the Assembly) – appointed Mr Şaban Dişli, Turkey, EPP/DC;

Other business:

- i. Refusing impunity for the killers of Sergei Magnitsky (Rapporteur: Mr Andreas Gross, Switzerland, SOC): noted that the Rapporteur intends to present, at the first committee meeting during the January 2014 part-session, an addendum and a preliminary draft recommendation relating to his report:
- ii. Strengthening the protection and role of human rights defenders in Council of Europe member States", (Ms Mailis Reps, Estonia, ALDE): following the Rapporteur's fact-finding visit to Armenia, Azerbaijan and Georgia, agreed to hold an exchange of views with an expert (subject to the availability of funds) during the January 2014 part-session;
- iii. Agreed to the proposal of Ms Marina Schuster, (Germany, ALDE), General Rapporteur for the Death Penalty, to issue a statement regarding Texas death row inmate, Mr Edgar Tamayo Arias, and for her to write to the relevant authorities recalling the need to implement the ICJ's Avena judgment;
