Synopsis of the meeting held in Strasbourg from 7 to 10 April 2014

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg from 7 to 10 April 2014:

- **on Monday 7 April 2014 at 2pm**, with Mr James Clappison (United Kingdom, EDG) in the Chair as regards:
- Improving user protection and security in cyberspace (Rapporteur for opinion: Mr Arcadio Díaz Tejera, Spain, SOC) considered a report tabled by the Committee on Culture, Science, Education and Media and approved the Committee's opinion including three amendments to the draft resolution;

Appointment of rapporteurs:

- i. Freedom of religion and religious practices (for opinion): Rapporteur for Committee on Culture, Science, Education and Media: Mr Rafael Huseynov (Azerbaijan, ALDE): Sir Edward Leigh (United Kingdom, EDG);
- ii. Evaluation of the Partnership for democracy in respect of the Palestinian National Council (follow-up to Resolution 1969 (2014)) (for opinion): Rapporteur for the Committee on Political Affairs and Democracy: Mr Jordi Xuclà, Spain, ALDE: appointed Mr Şaban Dişli (Turkey, EPP/CD);
- Judicial Corruption: urgent need to implement the Assembly's proposals (Rapporteur: Mr Kimmo Sasi, Finland, EPP/CD) considered an introductory memorandum and agreed to hold a hearing at the next meeting in Helsinki, with two experts, subject to the availability of funds;
- Request for Partner for Democracy status with the Parliamentary Assembly submitted by the Parliament of the Kyrgyz Republic (Rapporteur for opinion: Mr Pedro Agramunt, Spain, EPP/CD) considered a report tabled by the Committee on Political Affairs and Democracy and approved the Committee's opinion including ten amendments to the draft resolution;

Other business:

- "Fight against torture: the role of national monitoring bodies": authorised an exchange of views with the participation of two experts at the forthcoming meeting in Helsinki, subject to the availability of funds;
- **Need to reinforce the independence of the European Court of Human Rights** (Rapporteur: Mr Boriss Cilevičs, Latvia, SOC): agreed at the request of the Rapporteur to change the title of this report to "Reinforcement of the independence of the European Court of Human Rights." and to declassify the minutes pertaining to the hearing on this subject held on 6 November 2013;
- **Extension of deadlines:** agreed to request the Bureau to extend the references of "Strengthening the protection and role of human rights defenders in Council of Europe member states" (Rapporteur: Ms Mailis Reps, Estonia, ALDE) until 31 March 2015 and "European institutions and human rights in Europe" (Rapporteur: Mr Michael McNamara, Ireland, SOC) until 31 January 2015;

- Vaclav Havel Prize: took note of the call for candidatures and the upcoming deadline;
- on Tuesday 8 April 2014 at 2pm, with Mr McNamara (Ireland, SOC) in the Chair, as regards:
