**Synopsis No. 2007/10** 8 March 2007

The Committee on Migration, Refugees and Population, meeting in Brussels, on 1 and 2 March 2007, first with Mr Çavuşoğlu (Turkey, EDG) and then with Mr Branger (France, EPP/CD) in the Chair,

As regards:

- Cooperation with the Committee on Civil Liberties, Justice and Home Affairs of the European Parliament: heard a statement by Mr Branger, Chair of the Ad Hoc Sub-Committee which took part in a Seminar on the new Community Code on Visas in Brussels, on 28 February 2007;
- European Commission Recent initiatives in the field of migration and integration: held an exchange of views with Mr Stefano Bertozzi, member of the Private Office of Mr Franco Frattini, Commissioner responsible for Justice, Freedom and Security;
- **Europe's response to humanitarian disasters** (Rapporteur: Mr Mooney, Ireland, ALDE): held an exchange of views with Mr Johannes Luchner, Representative of the Directorate General for Humanitarian Aid (ECHO) of the European Commission and with Mr Sergio Piazzi, Representative of the United Nations Office for the Coordination of Humanitarian Affairs (OCHA), and authorised the Rapporteur to undertake a fact-finding visit to the UN Headquarters in New York in April 2007, in the framework of the preparation of the report (without cost to the Assembly and subject to the authorisation by the Bureau);
- Situation of irregular migrants: held an exchange of views with Mrs Michèle Le Voy,
   Representative of the Platform for International Cooperation on Undocumented Migrants (PICUM);
- **Regularisation programmes for irregular migrants** (Rapporteur: Mr Greenway, United Kingdom, EDG): heard a statement by the Rapporteur and authorised him to undertake a fact-finding visit to Italy, in the framework of the preparation of his report (without cost to the Assembly);
- European Council of Refugees and Exiles (ECRE): held an exchange of views with Mr
   Richard Williams, Representative of ECRE;
- Migration and mobility in the Eurasian region prospects for the future (Rapporteur : Mr Özal, Turkey, EPP/CD): took note of a memorandum;
- State of human rights and democracy in Europe (Rapporteur for opinion: Mr van Thijn, Netherlands, SOC): considered a preliminary draft opinion and approved its contribution to the report on the State of human rights and democracy in Europe:
- Activities of the International Organization for Migration (IOM) (Rapporteur: Mrs Hajiyeva, Azerbaijan, EPP/CD): considered a revised memorandum and held an exchange of views;
