- Improving the quality and consistency of asylum decisions in the Council of Europe Member States (Rapporteur: Mr Cilevičs, Latvia, SOC): organised a hearing on the case of France, with the participation of
 - Mr Pierre HENRY, Director General, France terre d'Asile
 - Mr Benoît MESLIN, Secretary General, OFPRA (Office français de protection des réfugiés et apatrides)

- State of democracy in Europe measures to improve the democratic participation of migrants (Rapporteur: Mr Greenway, United Kingdom, EDG): approved a draft report, adopted a draft resolution and a draft recommendation as amended, held an exchange of views on the Conference on Democracy in Europe which will take place in Strasbourg, on 24 June 2008 and asked its members who wish to take part in the event to inform the secretariat;
- Europe's "boat-people", mixed migration flows by sea into Southern Europe (Rapporteur: Mr Østergaard, Denmark, ALDE):): approved a draft report, adopted a draft resolution and a draft recommendation as amended and decided to issue a press release;
- Housing, land and property considerations as part of durable solutions for refugees and displaced persons (Rapporteur: Mr Dendias, Greece, EPP/CD): considered an outline for the report, heard a statement by the Rapporteur and authorised him to make a fact-finding visit to Georgia and to Nagorno Karabakh, subject to the availability of funds;
- **Migration in Europe: a constant challenge** (Rapporteur: Mr Preda, Romania, EPP/CD): held an exchange of views with

 - Mr Günther SCHESKE, UNHCR Representative to the European institutions
- Detention of asylum seekers and irregular migrants in Europe (Rapporteur: Mrs Mendonça, Portugal, SOC): heard a statement by the Rapporteur and decided to request its Chair to ask the Bureau to extend the validity of the reference to the end 2009;
