**The Committee on Migration, Refugees and Population**, meeting in Strasbourg, on 24, 25 and 26 June 2008, with Mrs Jonker (Netherlands, EPP/CD) in the Chair,

- **ON 24 JUNE 2008, AT 8.30 AM**

- held an **exchange of views** with members of the *Tunisian Parliament*;

as regards:

- **Activities of the International Committee of the Red Cross (ICRC)** (*Rapporteur: Mr Hancock, United Kingdom, ALDE*): took position on an amendment proposed by the Rapporteur, on behalf of the Committee;

- **Conference on specific challenges facing European democracies – the case of diversity and migration and measures to improve the democratic participation of migrants (Strasbourg, 24 June 2008, from 5.00 to 8.00 pm)**: held an exchange of views on the programme of the conference and appointed the following members to take part: Mrs Acketoft (Sweden, ALDE), Mr Etherington (United Kingdom, SOC), Mr Greenway (United Kingdom, EDG), Mr Henderson (United Kingdom, SOC), Mr Keskin (Germany, UEL), Mrs Sburny (Austria, SOC);

- **Housing, land and property considerations as part of durable solutions for refugees and displaced persons** (*Rapporteur: Mr Dendias, Greece, EPP/CD*): considered a memorandum, heard a statement by the Rapporteur and decided to change the title to “Solving property issue of refugees and displaced persons”;

- **Readmission agreements: a mechanism for returning irregular migrants** (*Rapporteur: Mrs Strik, Netherlands, SOC*): considered an outline for the report, heard a statement by the Rapporteur and authorised her to visit the European institutions in Brussels in October 2008 (subject to the availability of funds);

- **Meeting of the plenary Committee in Geneva (25-26 November 2008)**: held an exchange of views with Mrs Christine McCafferty (United Kingdom, SOC), Chair of the Social, Health and Family Affairs Committee, on the three seminars to be held in Geneva and heard a statement by Mrs Tina Nebe, from the Office of the United Nations Population Fund in Geneva;

- **ON 25 JUNE 2008, AT 2.00 PM**

- held an **exchange of views** with members of the *Algerian Parliament and the South-African Parliament*

– **State of democracy in Europe - measures to improve the democratic participation of migrants** (*Rapporteur: Mr Greenway, United Kingdom, EDG*): took position on the amendments to the draft Resolution and to the draft Recommendation;

– **The problem of environmental refugees** (*Rapporteur: Mrs Ackefors (Sweden, ALDE)*): heard a short statement by the Rapporteur and decided to ask its Chair to write to the Bureau requesting that the motion on the *Challenges posed by climate change* (reporting Committee: Committee on the Environment, Agriculture and Local and Regional Affairs) be referred to the Committee for opinion;

• **ON 26 JUNE 2008, AT 2.00 PM, as regards:**

– **Activities of the International Committee of the Red Cross (ICRC)** (*Rapporteur: Mr Hancock, United Kingdom, ALDE*):

- took note that one amendment has been tabled (on behalf of the Committee);
- held an exchange of views with Mr Jakob Kellenberger, President of the International Committee of the Red Cross, with the participation of members of the Committee on Legal Affairs and Human Rights;
- decided to ask its Chair to write to the Bureau requesting that the motion on *Ban of cluster munitions* (reporting Committee: Political Affairs Committee) be referred to the Committee for opinion;

– **Migration in Europe: a constant challenge** (*Rapporteur: Mr Preda, Romania, EPP/CD*): held an exchange of views with Mr Hallvard Gorseth, Head of the Division on Gender and Anti-Trafficking Equality, Council of Europe;

- *European expatriates: relations to their countries of origin*: appointed Mrs Bilozir (Ukraine, EPP/CD);
- *The demographic future of Europe and migration*: appointed Mrs Hajiyeva (Azerbaijan, EPP/CD);

- *Intergovernmental seminar on “The linguistic integration of adult migrants” (Strasbourg, 26-27 June 2008)*: heard a statement by Mrs Strik (Netherlands, SOC)

- *Meeting of the Presidents of Justice and Home Affairs Committees on the themes of European coordination on immigration and strengthening judicial cooperation in the European Union (Paris, 15 September 2008)*: appointed its Chairperson, subject to the availability of funds;
