- Preventing harm to refugees and migrants in extradition and expulsion cases: Rule 39 indications by the European Court of Human Rights (Rapporteur: Mr Darchiashvili, Georgia, EPP/CD): approved and took position on amendments to the draft resolution and to the draft recommendation proposed by the Rapporteur on behalf of the Committee;
- Unaccompanied minors in Europe: issues of arrival, stay and return (Rapporteur: Ms Reps, Estonia, ALDE): decided to modify the title of the report as follows: "Unaccompanied children in Europe: issues of arrival, stay and return", considered and approved a report and adopted a draft resolution and a draft recommendation:
- Reconstitution and composition of the sub-committees: reconstituted its three sub-committees (Sub-Committee on Migration, Sub-Committee on Refugees and Sub-Committee on Population) and agreed their composition (see appendix);
- Exchanges of views: held exchanges of views with:
