## TO THE MEMBERS OF THE COMMITTEE ON MIGRATION, REFUGEES AND POPULATION

18 March 2011

The Committee on Migration, Refugees and Population, meeting in Brussels, on 15 and 16 March 2011, with Mr Chope (United Kingdom, EDG) in the Chair,

- On Tuesday 15 March 2011, as regards:
- Undocumented migrant children in an irregular situation: a real cause for concern (Rapporteur: Mr Agramunt, Spain, EPP/CD): held a hearing, with the participation, inter alia, of:
  - Ms Tine DEBOSSCHER, Expert on education issues, *Organisation Kruispunt migratie-integratie*, Brussels
  - Ms Michele LE VOY, Director, the Platform for International Cooperation on Undocumented Migrants (PICUM)
  - Ms Saphia MOKRANE, General practitioner, Brussels
  - Ms Carla VAN OS, Defence for Children, ECPAT The Netherlands;
- Statement by the Chair: held a discussion on the humanitarian situation in the Southern Mediterranean and decided to ask the Bureau to propose to the Assembly to hold a current affairs debate or alternatively a debate under urgent procedure at the April part-session on large scale arrival of irregular migrants, asylum seekers and refugees on Europe's Southern shores;
- Protecting migrant women in the labour market (Rapporteur: Ms Frahm, Denmark, UEL): in the
  absence of the rapporteur, considered and approved a report and adopted a draft resolution and a draft
  recommendation;
- The situation of Roma in Europe: movement and migration (Rapporteur: Ms Groth, Germany, UEL): considered an outline for the report and heard a statement by the rapporteur:
- The interception and rescue at sea of asylum seekers, refugees and irregular migrants (Rapporteur: Mr Díaz Tejera, Spain, SOC): heard a statement by the rapporteur and decided to ask the Bureau to extend the mandate until 30 June 2011;
- The portrayal of migrants and refugees during election campaigns (Rapporteur: Ms Dumery, Belgium, NR): heard a statement by the rapporteur;
- Reform of the Assembly: held a discussion on the basis of proposals by its chair, decided to invite Mr Mignon, Chairperson of the Ad Hoc Committee of the Assembly (France, EPP/CD), to an exchange of views at its next meeting during the April part-session and invited its Chair to prepare further proposals for consideration by the Committee in April, with a view to ultimately submitting this to the Ad Hoc Committee;

- Appointment of a rapporteur: appointed Mr Zernovski ("The former Yugoslav Republic of Macedonia", ALDE) rapporteur on "Trafficking of migrant workers for forced labour: time for a closer look" and heard a statement of lack of conflict of interest from him;
- Representation of the Committee at various events:
  - Conference on "The invisible borders: forced migrant destitution in Europe", organised by the Jesuit Refugee Service Europe (JRS) (Brussels, 29 March 2011): appointed Ms Dumery (Belgium, NR), at no cost to the Assembly;
  - Consultation meeting with certain Networks of European National Human Rights Structures (NHRSs) on the Council of Europe's activities in the field of migration", hosted by the Ombudsman of Greece (English only) (Athens, 5-6 May 2011): appointed Mr Dendias (Greece, EPP/CD), at no cost to the Assembly;
  - Joint Colloquy (Council of Europe / HCR) on the Role of Regional Human Rights Courts in Interpreting and Enforcing Legal Standards for the Protection of Forcibly Displaced Persons (Strasbourg, 15-16 June 2011): appointed Mr Cilevičs (Latvia, SOC), subject to the availability of funds and noted the interest of Mr Rzayev (Azerbaijan, EPP/CD) to attend if a replacement was needed.
- Replies from the Committee of ministers to texts adopted by the Assembly presented by the Committee: considered the replies to the following recommendations:
  - Recommendation 1900 (2010) on The detention of asylum seekers and irregular migrants in Europe
  - Recommendation 1910 (2010) on The impact of the global economic crisis on migration in Europe
  - Recommendation 1917 (2010) on Migrants and refugees: a continuing challenge for the Council
    of Europe
  - Recommendation 1926 (2010) on Voluntary return programmes: an effective, humane and costeffective mechanism for returning irregular migrants;
- Meeting of the plenary committee in Corfu (Greece): heard a statement by the Chair on the preliminary draft programme of the meeting;
- Demographic trends in Europe: turning challenges into opportunities: heard a statement by Ms Memecan (Turkey, ALDE), Rapporteur on "Demographic winter and the future of Europe", decided to change the title of her report to "Demograhic trends in Europe: turning challenges into opportunities" and held a hearing, with the participation, inter alia, of:
  - Ms Vitalija GAUCAITE WITTICH, UN Economic Commission for Europe, Geneva
  - Prof. François HERAN, President of the European Association for Population Studies (EAPS) and Research Professor at the National Institute for Demographic Studies (INED);
  - Prof. Ahmet ICDUYGU, Koç University, Turkey; Visiting Fellow at the European University Institute of Florenz, Italy
  - Ms Sietske STENEKER, Director of United Nations Population Fund (UNFPA), Brussels office
