# To the members of the Committee on Migration, Refugees and **Displaced Persons**

# Synopsis of the meeting held in Strasbourg on 21, 22, 23 and 24 January 2013

The Committee on Migration, Refugees and Displaced Persons, meeting in Strasbourg, with first Mr Jim Hood (United Kingdom, SOC), oldest person present, and then Mr Giacomo Santini (Italy, EPP/CD) in the Chair.

- on Monday 21 January 2013 at 2 p.m., as regards:
- A minute's silence was observed in memory of the former President of the Assembly, Mr Lluís Maria de Puig, who died in December 2012;
- Election of the Committee's Bureau:

  - elected Mr Giacomo Santini (Italy, EPP/CD) Chairperson by acclamation; elected Mr Tuğrul Turkes (Turkey, EDG) 1<sup>st</sup> Vice-Chairperson by acclamation; elected Ms Tineke Strik (Netherlands, SOC) 2<sup>nd</sup> Vice-Chairperson by acclamation; elected Mr Gebhard Negele (Liechtenstein, EPP/CD) 3<sup>rd</sup> Vice-Chairperson by acclamation;
- Migration and asylum: mounting tensions in the Eastern Mediterranean: appointed Ms Tineke Strik (Netherlands, SOC) as Rapporteur;
- Constitution of the Sub-Committees: decided to reconstitute the following Sub-Committees:
  - Sub-Committee on Integration,
  - Sub-Committee on Detention,
  - Sub-Committee on Co-operation with non European countries of origin and transit,

and decided to reconstitute the Ad hoc Sub-Committee on large-scale arrival of irregular migrants, asylum-seekers and refugees on Europe's Southern shores;

- FRONTEX: the need to improve its human rights role and capabilities: in the absence of the Rapporteur, considered a preliminary draft report;
- Refugees and the fight against AIDS: held an exchange of views with Mr Harry Witzthum, Head of Development, Swiss Aids Federation and heard a statement on the Rapporteur's fact-finding mission to Moscow (21 November 2012); decided to change the title of the report to "Migrants and refugees and the fight against AIDS"; authorised the Rapporteur to carry out a fact-finding visit to Portugal in the framework of the preparation of her report;
- Missing persons from Europe's conflicts: the long road to finding humanitarian answers: heard a statement on the Rapporteur's fact-finding mission to Geneva (3 December 2012);

- on Tuesday 22 January 2013 at 2 p.m., as regards:
- Composition of the Sub-Committees: agreed the composition of the three reconstituted Sub-Committees as well as the reconstituted Ad hoc Sub-Committee on large-scale arrival of irregular migrants, asylum seekers and refugees on Europe's Southern shores (see appendix);
- Ad hoc Sub-Committee on the large-scale arrival of irregular migrants, asylum-seekers and refugees on Europe's Southern Shores: heard a statement on the fact-finding mission to Athens (Greece) and the Greek-Turkish border (14-16 January 2013);
- Migration and asylum: mounting tensions in the Eastern Mediterranean: heard a declaration of absence of conflict of interest from the rapporteur; approved a draft report and adopted a draft resolution and a draft recommendation;
- **Georgia and Russia: the humanitarian situation in the conflict- and war-affected areas**: took position on the amendments tabled to the draft resolution and the draft recommendation;
- on Wednesday 23 January 2013 at 2 p.m., as regards:
- Joint hearing with the Committee on Equality and Non-Discrimination: held a joint hearing on "Refugee women and the Istanbul Convention - preventing and combating sexual and gender-based violence", organised by the Parliamentary network "Women free from violence" in cooperation with UNHCR;
- on Thursday 24 January 2013 at 8.30 a.m., as regards:
- Migration and asylum: mounting tensions in the Eastern Mediterranean: took position on the amendments tabled to the draft resolution and the draft recommendation;
- on Thursday 24 January 2013 at 2 p.m., as regards:
- **Trafficking of migrant workers for forced labour**: took position on the amendments tabled to the draft resolution;
- Integration tests for migrants: a step forward or back?: held an exchange of views with Mr Christopher Hedges, former Chairperson of the European Committee on Migration (CDMG), and considered a revised memorandum;
- Integration of migrants: is Europe failing?: heard a statement on the Rapporteur's fact-finding mission to visit the Federal Office for Migration and Refugees (BAMF) in Nuremburg (8-9 January 2013);
- **Effective and fair returns of irregular migrants and failed asylum seekers**: in the absence of the Rapporteur, authorised the Rapporteur to carry out a fact-finding visit on a joint-enforced return flight;
- Management of mixed migration and asylum challenges beyond the European Union's Eastern border. in the absence of the Rapporteur, took note of a preliminary draft report;
- Replies from the Committee of Ministers to texts adopted by the Assembly presented by the Committee: considered the joint reply to the following recommendations:
  - Recommendation 1967 (2011) on The large-scale arrival of irregular migrants, asylum seekers and refugees on Europe's southern shores,
  - Recommendation 1969 (2011) on Unaccompanied children in Europe: issues of arrival, stay and return
  - Recommendation 1973 (2011) on Asylum seekers and refugees: sharing responsibilities in Europe
- Training for Parliamentarians on visiting places of detention where irregular migrants and asylum seekers are held: heard a statement on the training held in Strasbourg (4-5 December 2012);

- appointed Mr Giacomo Santini (Italy, EPP/CD) to participate in the Conference on "Intercultural Cities: making diversity work for cities" in Dublin, Ireland, 6 to 8 February 2013 (subject to the availability of funds);
