Synopsis of the meeting held in Strasbourg on 27, 29 and 30 January 2014

The Committee on Migration, Refugees and Displaced Persons, meeting in Strasbourg, with first Mr Tadeusz Iwiński (Poland, SOC), oldest person present, and then Mr Thierry Mariani (France, EPP/CD) and Mr René Rouquet (France, SOC) in the Chair,

- on Monday, 27 January 2014 at 2 p.m., as regards:
- **Election of the Committee's Bureau:** elected Mr Thierry Mariani (France, EPP/CD) Chairperson by acclamation;
- Appointment of Rapporteurs:
 - Integration of migrants: is Europe failing?: appointed Ms Marietta Karamanli (France, SOC) as Rapporteur and heard from her a declaration of absence of conflict of interest;
 - The arrival of large numbers of irregular migrants to Italian coastal areas as a result of tensions in the Southern Mediterranean countries: appointed Mr Christopher Chope (United Kingdom, EDG) as Rapporteur and authorised him to carry out a fact-finding visit to Italy, subject to the availability of financial resources by the Assembly;
 - **Political participation for migrant Diaspora**: appointed Mr Andrea Rigoni (Italy, ALDE) as Rapporteur and heard from him a declaration of absence of conflict of interest;
- **Constitution of the Sub-Committees**: decided to reconstitute the following Sub-Committees:
 - Sub-Committee on Integration,
 - Sub-Committee on Detention,
 - Sub-Committee on Co-operation with non European countries of origin and transit,

and decided to reconstitute the a*d hoc* Sub-Committee on large-scale arrival of irregular migrants, asylum-seekers and refugees on Europe's Southern shores;

- Alternatives to Europe's sub-standard IDP collective centres (Rapporteur: Mr René Rouquet, France, SOC): considered a preliminary draft report;
- The "left-to-die boat": actions and reactions (Rapporteur: Ms Tineke Strik, Netherlands, SOC): held an exchange of views with Mr Giulio di Blasi, representative of the EU Task Force Mediterranean, European Commission, DG Home Affairs and considered an outline for a report;

- on Wednesday, 29 January 2014 at 2 p.m., as regards:
- Election of the Committee's Bureau: elected:
 - Ms Tülin Erkal Kara (Turkey, EDG) 1st Vice-Chairperson by acclamation;
 - Mr René Rouquet (France, SOC) 2nd Vice-Chairperson by acclamation;
 - Ms Anne-Mari Virolainen (Finland, EPP/CD) 3rd Vice-Chairperson by acclamation;
- Composition of the Sub-Committees: agreed the composition of the three Sub-Committees as well as the *ad hoc* Sub-Committee on large-scale arrival of irregular migrants, asylum seekers and refugees on Europe's Southern shores (see appendix);
- **Syrian refugees: how to organise and support international assistance?** (Rapporteur: Mr Jean-Marie Bockel, France, EPP/CD): took position on the amendments tabled to the draft resolution;
- *Migrants: ensuring they are a benefit for European host societies* (Rapporteur: Ms Athina Kyriakidou, Cyprus, SOC): took position on the amendments tabled to the draft resolution;
- Immigration detention of children (Rapporteur: Ms Tinatin Bokuchava, Georgia, EPP/CD): heard a statement by the rapporteur and authorised her to carry out a fact-finding visit to Sweden, subject to the availability of financial resources by the Assembly;
- Access to nationality and the effective implementation of the European Convention on Nationality (Rapporteur for opinion: Mr Rafael Huseynov, Azerbaijan, ALDE): approved a draft opinion;
- Political participation for migrant diaspora (Rapporteur: Mr Andrea Rigoni, Italy, ALDE): considered an outline for a report, decided to modify the title of the report as follows: "Democratic participation for migrant diaspora" and appointed the rapporteur to participate in a High-Level Conference on "Diaspora and Development" organised by the Crans Montana Forum in Brussels on 20 February 2014, subject to the availability of financial resources by the Assembly;
- Resettlement of refugees: an efficient tool for greater solidarity in Europe (Rapporteur: Mr Eric Voruz, Switzerland, SOC): heard a statement by the Rapporteur on the fact-finding visit to Bern and Geneva (5-6 November 2013) and considered a preliminary draft report;
- 2nd training for Parliamentarians on visiting places of detention for irregular migrants and asylum seekers (Zurich, 16-17 October 2013): heard a statement by Ms Doris Fiala (Switzerland, ALDE) and approved a draft report on the training exercise;
- **The right to work for refugees** (Rapporteur: Mr Christopher Chope, United Kingdom, EDG): considered a preliminary draft report;
- Joint hearing on "The need to eliminate statelessness" (April 2014 part-session): heard a presentation by the new Representative of the United Nations High Commissioner for Refugees (UNHCR) to the European Institutions in Strasbourg, Mr Gerhard Westerveen, and took note of the forthcoming hearing on Statelessness to be jointly organised by UNHCR, the Committee on Migration, Refugees and Displaced Persons and the Committee on Legal Affairs and Human Rights on 9 April 2014;
- on Thursday, 30 January 2014 at 8.30 a.m., as regards:
- Follow-up to the situation of migrants and refugees in Morocco: a new approach: heard a statement by Mr Driss El Yazami, President of the National Council of Human Rights of Morocco with the participation of Ms Gabriella Battaini-Dragoni, Deputy Secretary General of the Council of Europe;
- Unaccompanied migrant children: what rights at 18? (Rapporteur: Ms Mailis Reps, Estonia, ALDE): held an exchange of views with Ms Lilana Keith, Programme Officer, Platform for International Cooperation on Undocumented Migrants (PICUM) and considered a preliminary draft report;
- Chinese migration to Europe: challenges and opportunities (Rapporteur: Mr Thierry Mariani, France, EPP/CD): held an exchange of views with Mr Frank Laczko, Head of Migration Research Division, International Organization for Migration (IOM);

- The arrival of large numbers of irregular migrants to Italian coastal areas as a result of tensions in the Southern Mediterranean countries (Rapporteur: Mr Christopher Chope, United Kingdom, EDG): heard a statement by the rapporteur on the future fact-finding visit to Italy on 10-12 February 2014;
