Liste des arrêts de la Cour de Strasbourg qui n'ont pas été pleinement mis en œuvre plus de cinq ans après leur prononcé ou qui soulèvent d'importants problèmes de mise en œuvre par rapport à 36 Etats parties à la CEDH

I. Remarques préliminaires

1. Le présent addendum donne des informations sur tous les grands arrêts de la Cour européenne des droits de l'homme (ci-après dénommée « la Cour ») actuellement sous la surveillance du Comité des Ministres, qui rentrent dans le cadre des critères types appliqués par l'Assemblée parlementaire pour identifier les cas de mise en œuvre particulièrement difficiles, à savoir :

- les arrêts dont la mise en œuvre complète n'est toujours pas acquise plus de cinq ans après leur prononcé ;
- les autres arrêts ayant soulevé d'importantes questions de mise en œuvre, qu'elles soient individuelles ou générales, et sur lesquelles le Comité des Ministres a notamment mis l'accent dans ses résolutions intérimaires et autres documents¹.

2. Rentrent notamment dans cette dernière catégorie des arrêts qui suscitent des préoccupations en raison de violations systématiques des droits de l'homme et/ou de violations présentant un caractère particulièrement grave (en particulier des dispositions de la Convention auxquelles il est impossible de déroger). S'agissant du premier critère, je propose que le septième rapport sur la *mise en œuvre des arrêts de la Cour européenne des droits de l'homme* soit présenté l'année prochaine en juin. En conséquence, pour recenser les arrêts qui relèvent des critères types, la date choisie pour appliquer le critère de non-exécution pendant cinq ans est celle du 15 juin 2010.

3. Comme indiqué dans le rapport d'activité, il ne m'appartient pas en ma qualité de rapporteur unique, pas plus qu'il n'est intéressant compte tenu du système existant de supervision, de traiter des nombreux arrêts qui relèvent actuellement des critères types. Néanmoins, si l'application de ces critères ne suffit plus à mettre en évidence les cas les plus délicats de non-exécution, la gravité des violations reconnue dans les arrêts rentrant dans le cadre des critères types ne s'en trouve pas réduite et il est impérieux d'exécuter pleinement et rapidement ces arrêts. Le présent addendum vise

à faire apparaître le problème grave et très répandu de l'incapacité des Etats parties à exécuter pleinement et rapidement les arrêts de la Cour.

4. Les informations données se limitent à l'identification de l'arrêt de principe et des décisions examinées par le Comité des Ministres dans le cadre de sa fonction de surveillance. Pour un résumé des faits et de l'arrêt de la Cour et pour des informations concernant la mise en œuvre (mesures individuelles, mesures générales et dernière décision du Comité des Ministres), un lien renvoie à la partie pertinente du site web consacrée à l'exécution des arrêts de la Cour européenne des droits de l'homme². Ce site publie les toutes dernières informations en date concernant l'état d'exécution des arrêts de la Cour que le Comité des Ministres surveille actuellement, en application du paragraphe 2 de l'article 46 de la Convention européenne des droits de l'homme.
