**PACE project of parliamentary cooperation with the Parliaments of
Armenia, Azerbaijan, Belarus, Georgia, Republic of Moldova and Ukraine
in the framework of the Partnership for Good Governance (PGG)
Phase I, 2015-2017**

RATIONALE

The Eastern Partnership - subsequently Partnership for Good Governance (PGG) - was developed in 2014 within the programmatic Cooperation Framework (PCF), a new modality of cooperation between the European Union (EU) and the Council of Europe (CoE), for six partner countries: Armenia, Azerbaijan, Belarus, Georgia, Republic of Moldova and Ukraine. It was implemented through 3-years' phases as from 2015 until 2020 (see the link to the PGG pages : <https://pjp-eu.coe.int/en/web/eap-pcf/home?desktop=true>).

This joint programme, financed by the EU and the CoE and implemented by the Council of Europe, builds upon the CoE and the EU policies and priorities in the context of the 'Eastern Partnership' region and on the CoE expertise in standard-setting, monitoring and cooperation experience with its partners

Its main action plan for Phase I aimed at reinforcing the rule of law, enhancing the respect of human rights and promoting democratic governance, which are at the core of Council of Europe standards.

PACE PROJECT

PACE contributed to the Phase I, in 2015-2017, by developing parliamentary cooperation with the Parliaments of the region on peer to peer basis and by an awareness raising among Members of national parliaments of the necessity of their stronger involvement in democratic reforms and in guarantying the respect of human rights in their country.

PACE activities aimed at implementing its resolutions in the field. They were organised by the Parliamentary Project Support Division in co-operation with relevant PACE Committees and other partners and aimed at strengthening the role and structure of national parliaments of six partners to better ensure in the partner countries:

- Democratic governance through the improvement of democratic electoral system, which may ensure the right to free and fair elections to all citizens (*Resolution 1897 (2012) Ensuring greater democracy in elections*);
- Respect of human rights through an effective implementation of human rights standards of the European Convention on Human Rights in national legislation (including the European Social Charter) and through the supervision by the Parliament of the effective execution of ECtHR judgments (*Resolution 1823 National parliaments: guarantors of human rights in Europe and Resolution 17871 (2011) Implementation of judgments of the ECtHR*);

- Respect of freedom and transparency of Media, including public broadcasting, and safety of journalists (*Resolution 1920 (2013) on the state of media freedom in Europe*)

IMPLEMENTATION AND ACHIEVEMENTS

The Assembly organized 18 activities in 3 years: 6 activities in 2015, 5 activities in 2016 and 7 activities in 2017, with a total number of 793 participants registered: 402 parliamentarians (MPs) and 391 other participants (staff members of national parliaments, experts, NGOs, specific national or international organisations).

Four major themes have been developed in co-operation with the PACE Committees and other partners during our activities (*see also chronological calendar of implemented activities below*), which contributed first, to the awareness raising of Members of national parliaments of partner countries (with a limited impact on the Parliament of Belarus, which is no more member of the PACE), and then to their greater involvement and concrete actions leading to a better implementation of the above mentioned adopted texts of the Assembly as well as of Council of Europe standards in their countries:

- ❖ HUMAN RIGHTS: five activities were organised in co-operation with the Committee on Legal Affairs and Human Rights (AS/JUR) and two other major partners: the European Court of Human Rights (ECtHR) and the Department for the execution of the ECtHR judgments (DG I) – two regional parliamentary seminars on the role of national parliaments in implementing ECHR standards (Tbilisi, September 2015 and Budapest, June 2017), one regional capacity building seminar on ECHR for the staff of national parliaments (Strasbourg, March 2015) and two activities for the Parliament of Georgia (Strasbourg, April 2016 and Borjomi, March 2017);
- ❖ EUROPEAN SOCIAL CHARTER AS PART OF ECHR: four activities were organised in co-operation with the Committee on Social Affairs, Health and Sustainable Development (AS/SOC) – two parliamentary seminars on fostering social rights in the partner countries (Chisinau, May 2015 and Baku, June 2017), one parliamentary seminar on social, legal and economic protection of children and young people (Paris, October 2016) and one parliamentary seminar on ensuring equal employment opportunities and inclusion for all (Paris, 28 October 2017);
- ❖ ELECTIONS: four activities were organised in co-operation with the PACE Election observation and Interparliamentary co-operation Division (ELECT) and Venice Commission and with the participation of representatives of NGOs and CEC (Central Electoral Committees) – two regional parliamentary conference for six partner parliaments: one on the implementation of the right to free elections and applying CoE standards (Paris, June 2015) and one on the misuse of administrative resources during electoral processes (London, November 2017); also one national round table on electoral standards and electoral processes for the Parliament of Belarus (Minsk, May 2016) and one transversal joint parliamentary conference on Media freedom as a cornerstone for democratic elections (Berlin, July 2016)
- ❖ MEDIA: four activities were organised in co-operation with the PACE Committee on Culture, Science, Education and Media (AS/CULT) and Media and Broadcasting organs – one regional parliamentary conference on awareness raising of the safety of journalists (Kyiv, June 2015), two regional conferences on the role of national parliaments in improving freedom, independence and pluralism of media (London, April 2016 and Budapest, December 2017) as well as one transversal parliamentary conference (see elections) on Media freedom as a cornerstone for democratic elections (Berlin, July 2016).
