

## PACE Cooperation with the Parliamentary Assemblies with a view to achieving legislative improvements

### What is the goal?

- ▶ to better implement standards of the European Convention on Human Rights (ECHR) in the legislation of the beneficiary countries and to increase the role and the capacity of Parliaments to improve the supervision of their governments' initiatives as regards the execution of the European Court of Human Rights (ECtHR) judgments
- ▶ to increase the awareness of parliamentarians and parliamentary staff of the ECtHR case-law and systemic cases in respect of their country and of the necessity of their action to verify and improve existing laws so as to avoid recurrent violations and to reduce the number of cases before the ECtHR
- ▶ to foster legislative norms regarding the independence of media

### Who benefits from the Action?

- ▶ lawmakers and related staff in the parliaments of the beneficiary countries,
- ▶ Government Agent's Offices before the European Court of Human Rights of the beneficiary countries
- ▶ media professionals and journalists
- ▶ citizens in the Western Balkans countries, by improving justice and ensuring protection of human rights

### How will the Action work?

- ▶ through engaging in a peer to peer and continuous exchange between the Court Registry, Execution and HELP specialists, lawmakers and parliamentary staff to improve their understanding and knowledge of the ECHR as well as of practices and case-law of the Court and of the procedures of execution of ECtHR judgments
- ▶ by introducing in their daily work, the Handbook for parliamentarians "National parliaments as guarantors of human rights in Europe", available in local languages, which guides parliamentarians and the staff in their actions by giving them useful tools to fulfil their obligations of the protection of human rights in their country
- ▶ through close consultations and joint regional events, members of the PACE Committee on Culture, Science, Education and Media and its Sub-Committee on Media and Information Society representatives from media regulatory bodies, public service broadcasters and journalists will exchange views and discuss key reforms with lawmakers and staff of the specialized parliamentary committees

### What do we expect to achieve?

- ▶ Members of Parliament and parliamentary staff would be able to better apply the ECHR provisions in the legislation and develop necessary mechanisms for the supervision of the implementation of the ECtHR judgments
- ▶ Higher implementation the ECtHR judgments and strengthened awareness on the role of parliaments in the protection of fundamental human rights
- ▶ Improvement of media independence by revision of the legislation in the beneficiary countries

## How much will it cost?

- ▶ The total budget of the Action is 285 000 EUR.
- ▶ The budget allocated to the overall Horizontal Facility programme amounts to ca. 41 Million EUR (85% funded by the European Union, 15% by the Council of Europe).

The “Horizontal Facility for the Western Balkans and Turkey 2019-2022” is a joint initiative of the European Union and the Council of Europe that enables the Beneficiaries to meet their reform agendas in the fields of human rights, rule of law and democracy and to comply with the European standards, including where relevant within the framework of the EU enlargement process. This three-year programme covers actions in Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, Serbia, Turkey, as well as Kosovo\* and it is implemented by the Council of Europe from May 2019.
