Communication by the Secretary General of the Parliamentary Assembly at the 1207th meeting of the Ministers' Deputies¹ (17 September 2014)

¹ This document covers past activities of the Assembly since the meeting of the Bureau on 2 September 2014 (Paris) and the future activities up to the meeting of the Bureau on 29 September 2014 (Strasbourg).

I. Decisions taken by the Bureau

A. Fourth part-session of 2014 (29 September – 3 October 2014)

On 2 September 2014, the Bureau drew up the draft agenda (Appendix 1)

The award ceremony of the 2014 Václav Havel Human Rights Prize will be held on Monday 29 September at 12:30.

A list of side-events to be held during this part-session will be presented in an addendum to this communication, which will be available on the Committee of Ministers' extranet site on 23 September 2014.

B. Observation of elections

At its meetings, the Bureau took the following decisions:

- **Turkey: presidential election (10 August 2014):** took note of the press release of the ad hoc committee.
- **Bulgaria: early parliamentary elections (5 October 2014):** approved the final composition of the ad hoc committee with Ms Doris Fiala (Switzerland, ALDE) as its Chairperson (Appendix 2).
- **Bosnia and Herzegovina: general elections (12 October 2014):** approved the final composition of the ad hoc committee with Mr Tiny Kox (Netherlands, UEL) as its Chairperson (Appendix 3).
- **Republic of Moldova: parliamentary elections (30 November 2014):** approved the composition of the ad hoc committee and appointed Mr Jean-Claude Mignon (France, EPP/CD) as its Chairperson (Appendix 4).
- **Ukraine: early-parliamentary elections (26 October 2014):** decided to observe these elections and constituted an ad hoc committee for this purpose composed of 42 members: SOC: 13; EPP/CD: 13; EDG: 6; ALDE: 6; UEL: 2, as well the two co-rapporteurs of the Monitoring Committee; and authorised a pre-electoral mission.
- **Tunisia: parliamentary (26 October 2014) and presidential elections (23 November 2014):** decided to observe these elections; constituted an ad hoc committee for each of them composed of 11 members: SOC: 3; EPP/CD: 3; EDG: 2; ALDE: 2; UEL: 1, and authorised pre-electoral missions for both elections.

C. Other decisions taken by the Bureau at its meeting on 2 September 2014

- **World Forum for Democracy (Strasbourg, 3-5 November 2014):** the Bureau appointed Mr Michele Nicoletti (Italy, SOC) to represent the Assembly in the Steering Committee of the Forum in replacement of Ms Polonca Komar (Slovenia, ALDE).
- **Václav Havel Human Rights Prize:** the Bureau took note of the three candidates shortlisted by the Selection Panel of the Prize at its meeting in Prague on 26 August 2014 (in alphabetical order): B'Tselem Israeli Information Center for Human Rights (Israel), Jesuit Refugee Service Malta (Malta) and Mr Anar Mammadli (Azerbaijan).
- **Meetings elsewhere than in Strasbourg and Paris:** the Bureau authorised the Sub-Committee on Co-operation with non-European countries of origin and transit (of the Committee on Migration, Refugees and Displaced Persons) to meet in Rabat, on 23-24 October 2014.

II. European Conference of Presidents of Parliament

Presidents of Parliament from the 47 Council of Europe member states, as well as many neighbouring and observer countries, met on 11 and 12 September 2014 in Oslo, on the occasion of a conference organised by the Storting and the Parliamentary Assembly of the Council of Europe (PACE).

The 58 Speakers of Parliament discussed three major topical issues:

- Fundamental constitutional rights and freedoms – participation, trust and public debate as conditions for democracy
- Democracy, Sovereignty and Security in Europe
- Majority and opposition – striking a balance in democracy.

The conference was opened by the President of the Storting, Mr Olemic Thommessen, the President of Assembly, Ms Anne Brasseur, the Secretary General of the Council of Europe, Mr Thorbjørn Jagland, and the Norwegian Minister for European Economic Area and European Union Affairs, Mr Vidar Helgesen.

The conclusions of the Conference are available on the Assembly website.

III. Activities of Committees and Networks

- On 1 July 2014 in Rome, an ad hoc sub-committee of the **Committee on Rules of Procedure, Immunities and Institutional Affairs** held a parliamentary seminar on ***codes of conduct for parliamentarians and the prevention of corruption***.
- On 1 August 2014, the members of the **Parliamentary Network Women Free from Violence** celebrated the entry into force of the **Istanbul Convention** by visiting shelters for victims of violence and attracting media attention on violence against women and the role of the Council of Europe through press conferences and articles.
- On 4-5 September 2014 in Paris, the **Committee on Political Affairs and Democracy**:
 - held an exchange of views on the ***Situation in Gaza***, organised by the Sub-Committee on the Middle East and the Arab World, with the participation of Ms Rosemary Hollis, Professor of Middle East Policy Studies at City University, London, and Director, Olive Tree Programme and Mr Daniel Levy, Director of the Middle East and North Africa Programme at the European Council on Foreign Relations and welcomed an invitation from the Palestinian Delegation;
 - held an exchange of views on ***Violence against Christian communities in the Middle East and the South Mediterranean and its consequences*** (Rapporteur: Ms Theodora Bakoyannis, Greece, EPP/CD) and decided to propose to the Assembly a debate under urgent procedure on ***Threats posed by the 'Islamic State' (IS) and violence against Christians and other religious communities***, to be held during the 4th part-session;
 - held an exchange of views with a parliamentary delegation of the Jordanian House of Representatives in the framework of the preparation of the report on the ***Request for partner for democracy status with the Parliamentary Assembly submitted by the Parliament of Jordan*** (Rapporteur: Ms Josette Durrieu, France, SOC);
 - heard a statement by Ms Gabriella Battaini-Dragnoni, Deputy Secretary General of the Council of Europe, in the framework of the consideration of a preliminary draft report on ***The implementation of the Memorandum of Understanding between the Council of Europe and the European Union*** (Rapporteur: Ms Kerstin Lundgren, Sweden, ALDE);
 - held an exchange of views, organised by the Sub-Committee on relations with the OECD and the EBRD, with the participation of Mrs Gabriela Ramos, OECD Chief of Staff and Sherpa to

the G20, with a view to preparing the debate on the **Activities of the Organisation for Economic Co-operation and Development (OECD)** to be held during the 4th part-session, with the participation of the Secretary General of the OECD.

- On 6 September 2014 in Słupsk, (Poland), the **Europe Prize 2014** was officially presented.
- On 8 September 2014 in Paris, the **Committee on Equality and Non-Discrimination**:
 - held an exchange of views with Ms Brigitte Gonthier-Maurin, Chairperson of the Delegation for **Women's Rights and Equal Opportunities for Men and Women** of the French Senate;
 - held an exchange of views on **Equality and the crisis** with the participation of Mr Luis Jimena Quesada, President of the European Committee of Social Rights (ECSR).
- On 9 September 2014 in Nicosia, the Steering Group of the Project partnership between the Council of Europe Parliamentary Assembly and the A.G. Leventis Foundation (Cyprus) held its 4th meeting on **"Strengthening national policies to stop sexual violence against children: a Council of Europe project involving pilot initiatives in Cyprus"**.
- On 9 September 2014 in Paris, the **Committee on Migration, Refugees and Displaced Persons** held a hearing on **"Violence against migrants"** with the participation of Ms Claire Saas, Associate Professor of Criminal Law and Procedure, member of the GISTI (*Groupe d'Information et de soutien des immigrés*), Ms Eva Cossé, Senior Research Assistant, Europe and Central Asia Division, Human Rights Watch, Ms Anastasia Denisova, Civic Assistance Committee, Moscow and Ms Patricia Ötvös, Adviser, Office of the Council of Europe Commissioner for Human Rights.

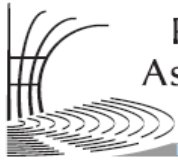
