## **I. Decisions taken by the Bureau on 28 February 2019**

### **A. Second part-session of 2019 (8-12 April 2019)**

On 28 February 2019, the Bureau drew up the draft agenda (Appendix I).

On 18 March 2019, the Committee on Rules of Procedure, Immunities and Institutional Affairs decided to request that a debate under urgent procedure on “*The budgetary crisis at the Council of Europe*” be held at the 2019 April part-session of the Assembly.

A list of events to be held during this part-session is appended to this communication (Appendix 2).

### **B. Observation of elections**

- **Republic of Moldova: parliamentary elections (24 February 2019):** the Bureau took note of the statement of the election observation mission. The statement is available on the website of the Assembly;
- **Ukraine: presidential election (31 March and 21 April 2019):** the Bureau approved the final list of members of the ad hoc committee to observe this election (Appendix 3);
- **North Macedonia: presidential election (21 April 2019):** the Bureau approved the updated list of members of the ad hoc committee to observe this election (Appendix 4).

### **C. Other decisions**

- **Formation of a new political group: New European Democrats/Europe of Nations and Freedom (NED/ENF):** the Bureau held an exchange of views with Mr Martin Graf, Chairperson of the NED/ENF Group; took note of the information provided and decided to ask - in the context of the formation of the NED/ENF Group - the Committee on Rules of Procedure, Immunities and Institutional Affairs for advice on the procedure defined in Art. 19.1 of the Rules of Procedure.

### III. Prizes

#### ➤ **Council of Europe Museum Prize**

The winner of the 2019 Museum Prize is the Museum of Communication of Bern. The award ceremony will take place on Tuesday 9 April 2019 in *Palais Rohan*, Strasbourg at 8.30 pm.

#### ➤ **Europe Prize**

The Europe Prize is the highest distinction that can be bestowed on a European town for its actions in the European domain. It includes a trophy, a medal, a diploma and a scholarship to be spent on a study visit within Europe by young people from the winning municipality.

On 11 April 2019, the Sub-Committee on the Europe Prize will consider the finalists for the 2019 Europe Prize (Bamberg in Germany, Bolesławiec in Poland, Issy-les-Moulineaux in France, Izmir in Turkey, Münster in Germany and San Sebastián in Spain). The applications for the Plaque of Honour, the Flag of Honour and the European Diploma will also be considered at that same meeting.

#### ➤ **Václav Havel Human Rights Prize**

This Prize is awarded annually by the Parliamentary Assembly of the Council of Europe, in partnership with the Václav Havel Library, the Charta 77 Foundation and the Government of the Czech Republic, in memory of Václav Havel.
