### **Activity report 2016**

#### **Information memorandum**

## Introduction

1. Since 2012, the mandate of the Committee on Equality and Non-Discrimination is related to gender equality and all aspects of the fight against discrimination, on whatever ground (gender, age, national or social origin, sexual orientation, disability, etc.), as well as all forms of racism and intolerance.

2. Reviews of the committee's activities were carried out by my predecessors for the periods 2012-2013 and 2014-2015.<sup>1</sup> They provided useful guidelines for the committee's work. The purpose of this memorandum is to take stock of the activities of the committee in 2016 in order to facilitate the forthcoming discussions on the activities and working structures of the committee in 2017.

### 1. Thematic coverage

3. The work of the Committee on Equality and Non-Discrimination centred on its four main themes: equality and equal opportunities across the board, gender equality, including combating violence against women, the rights of minorities including Roma and Travellers, and preventing and combating racism and intolerance. The committee also tackled more specific themes such as the rights of persons with disabilities and discrimination on grounds of sexual orientation.

#### 1.1 Women in public space project

4. As Chairperson of this committee, I took the initiative to launch a project called "Women in public space", which aims to structure the activities of the committee in the field of gender equality and to develop a holistic approach.<sup>2</sup> Under this item on its agenda, the committee discusses the issue of equality between women and men in various areas (economy, education, political representation, etc.). Several exchanges of views and hearings were organised during the year, including through joint meetings with other committees of the Parliamentary Assembly, such as the Committee on Migration, Refugees and Displaced Persons and the Committee on Culture, Science, Education and Media.<sup>3</sup>

5. Through this project, the attention given by our committee to gender equality and its cross-cutting aspects has increased. It has also contributed to disseminating a gender equality perspective in the work of other committees of the Assembly and to strengthening co-operation with the relevant bodies of the Council of Europe such as the Gender Equality Commission and other international bodies and institutions.

#### 1.2 Reports and opinions

6. In 2016, the committee adopted **9 reports**, among which 6 were debated at plenary sessions and meetings of the standing committee.<sup>4</sup> The 3 other adopted reports will be debated in 2017. The themes addressed were as follows:

- violence against women (3 reports),
- gender equality (2 reports),
- racism, intolerance and hate speech (2 reports),
- combating discrimination on the grounds of religion (1 report),
- Roma and Travellers (1 report).

7. For the first time since 2006,<sup>5</sup> the committee was seized by the Assembly for an urgent debate following the Cologne attacks against women on 31 December 2015. This urgent debate on "Recent attacks against women in European cities - the need for a comprehensive response" had one of the highest media coverages during the January part-session of the Assembly.<sup>6</sup> Our committee is in charge of the follow-up to Resolution 2093 (2016) and will present in 2017 a report on "Putting an end to sexual violence and harassment of women in public space" (rapporteur: Ms Françoise Hetto-Gaasch).

8. For the preparation of the reports, **8 fact-finding visits** were carried out: to Austria, Belgium (NATO), Bulgaria, Hungary, Germany, Sweden and the United Kingdom.

9. The variety of the subject matters is a feature of the reports currently being prepared which will be adopted and possibly debated in 2017:

- violence against women (2 reports),
- gender equality (2 reports),
- combating discrimination, including on the grounds of disability (1 report),
- the rights of LGBTI people (1 reports),

10. In 2016, the committee also presented **4 opinions**.<sup>7</sup> The list of these opinions shows that the committee played a major role in the process of awarding neighbouring states partner for democracy status and its implementation. The committee was also, for the first time, involved in the debates regarding the fight against radicalisation and terrorism. These opinions helped to increase the visibility of the committee and its various themes (notably women's rights, the rights of LGBT people and the fight against discrimination).

## 2. Diversification and visibility of activities and structures

11. In 2016, the committee pursued its goal of diversifying its activities, striking an effective balance between report-drafting and other activities aimed at heightening the impact and prominence of its work.

### 2.1 Parliamentary networks

12. The **Parliamentary Network Women Free from Violence** pressed ahead with its efforts to raise awareness and promote the Istanbul Convention, thanks to the voluntary contributions which it received, in particular from Germany and the Netherlands.<sup>8</sup> In 2016, the Network focused on the role of national parliaments in implementing the Istanbul Convention, notably by establishing fruitful working relations with the Group of Experts on Action against Violence against Women and Domestic Violence (GREVIO) and by promoting the Network members as facilitators and interlocutors during the monitoring phase carried out by the GREVIO. The Network also strengthened its relations with the Committee on Women's Rights and Gender Equality (FEMM) of the European Parliament, notably in the context of the decision taken by the European Union to join the Istanbul Convention. Two newsletters were issued in 2016. The German, English, French and Azerbaijani versions of the Handbook for parliamentarians on the Istanbul Convention were updated. To date, the Handbook is available in 14 languages.<sup>9</sup>

13. The **No Hate Parliamentary Alliance** developed its activities through national seminars (in Italy, France and Bosnia and Herzegovina) and hearings on issues such as anti-Gypsyism in Europe and violence and discrimination on the ground of ethnic origin. Its coordinator and members participated in several meetings organised by key partners such as the OSCE and the Anti-Racism and Diversity Intergroup (ARDI) of the European Parliament. Co-operation with the Council of Europe No Hate Speech Movement was reinforced through mutual invitations to events and joint initiatives. As of 1 November 2016, the Alliance had 56 members.

### 2.2 General rapporteurs and sub-committees

14. The **three general rapporteurs** (on violence against women, on the rights of LGBT people and on combating racism and intolerance) have helped to raise awareness of the issues within their respective remits and to raise the Assembly's profile in these areas by participating in external events and making public statements.

15. The terms of reference of the **three sub-committees** (on gender equality, on the rights of minorities and on disability and inclusion) were renewed in 2016 and hearings were held during the Assembly sessions, as well as in Berlin and Paris. Each sub-committee met twice in 2016.

### 2.3 Visibility

16. The visibility of the committee's work was significantly increased over the period under review, thanks to social media. The hearings held in connection with the No Hate Parliamentary Alliance and the Parliamentary Network Women Free from Violence were relayed on social media. The network's Facebook page has grown significantly and in November 2016, the number of *likes* passed the 2,450 mark. In addition, the Twitter account of the committee (@PACE\_Equality) greatly contributed to providing real-time information on the activities of the committee and its members. It reached 450 followers in November 2016 and the number has continued to grow since then. The Twitter account is followed by key governmental and non-governmental organisations working in the field of equality and non-discrimination, which also disseminate information about our activities.

## 3. Co-operation

### 3.1 Co-operation with other Assembly committees and Council of Europe structures

17. In carrying out its activities, the committee attached considerable importance to co-operation with other Assembly committees, thus recognising the cross-cutting nature of many of the issues that it tackles.

18. As mentioned above, in the context of the "Women in public space" project, joint meetings were organised with the Committee on Migration, Refugees and Displaced Persons in June, and with the Committee on Culture, Science, Education and Media in October.

19. I also participated in the meetings of the Committee on the Election of Judges to the European Court of Human Rights, where the chair of the Committee on Equality and Non-Discrimination sits in an *ex officio* capacity. This participation enables our committee to have a say in the process of selecting judges for the European Court of Human Rights and to introducing a gender perspective to this process.

20. At the same time, the committee established good working relations with the main Council of Europe bodies working in its areas of competence. I participated in the meetings of the Gender Equality Commission (GEC) of the Council of Europe in May and the Chair of the GEC was invited to speak before our committee in September. The committee also held exchanges of views with the Commissioner for Human Rights, the European Commission against Racism and Intolerance (ECRI) and other bodies which come under the Directorate General of Democracy of the Council of Europe.

### 3.2 Co-operation with other international organisations and institutions

21. In 2016, the committee and its parliamentary networks held exchanges of views with or organised events involving representatives of the following bodies:

- European Parliament (FEMM and LIBE committees, ARDI),
- Inter-Parliamentary Union (IPU),
- Office of the United Nations High Commissioner for Human Rights (OHCHR),
- Office of the United Nations High Commissioner for Refugees for Europe (UNHCR),
- Organisation for Economic Co-operation and Development (OECD),
- National human rights institutions.

22. Co-operation with parliamentary partners proved to be very positive and greatly contributed to improving the visibility and impact of the work of the Assembly in the fields of equality and non-discrimination.

## 4. Guest speakers

23. The committee had the honour of welcoming a number of prominent figures to its thematic exchanges of views. Ms Esabelle Dingizian, Third Deputy Speaker of the Riksdag (Sweden), Ms Åsa Regnér, Minister for Children, the Elderly and Gender Equality, Ministry of Health and Social Affairs of Sweden, Ms Alice Bah Kuhnke, Minister for Culture and Democracy of Sweden, Ms Ulla Schmidt, Vice-Chairperson of the Bundestag (Germany), Mr Christian Lange, Parliamentary State Secretary of the Federal Ministry of Justice and Consumer Protection of Germany, and Ms Elke Ferner, Parliamentary State Secretary of the Federal Ministry of Family, Senior Citizens, Women and Youth of Germany attended meetings of the committee, the No Hate Parliamentary Alliance and the Parliamentary Network Women Free from Violence.

## **5. Attendance and members' involvement**

24. The average attendance rate for committee meetings increased in 2016, reaching 51% (compared with 41% in 2015). This increase is particularly significant for committee meetings held outside Strasbourg, whose average attendance rate rose from 27% in 2015 to 37% in 2016. It should however be pointed out that attendance at sub-committee meetings remains extremely low overall, in particular during Assembly sessions, with some meetings failing to attract more than four members of the sub-committee concerned.

25. As regards the gender distribution amongst the rapporteurs, out of 10 reports and opinions debated in 2016, 7 rapporteurs were women and 3 were men, whereas men account for 45% of the members of the committee. I would thus encourage the male members of the committee to play a more active part in the work of the committee and to volunteer to act as rapporteurs.

26. Last but not least, I would like to congratulate the members acting as rapporteurs, general rapporteurs, bureau members, members of the Parliamentary Network Women Free from Violence and the No Hate Parliamentary Alliance and all the members who have actively participated in the committee's work on their involvement and readiness to assist. In 2016, new members have also joined the committee and contributed positively to making its meetings lively and stimulating.
