



## TO THE MEMBERS OF THE ASSEMBLY

### Secretariat of the Assembly

#### Synopsis

12 March 2010

**The Bureau of the Assembly**, meeting on Thursday 11 March 2010 in Paris, with Mr Mevlüt Çavuşoğlu, President of the Assembly, in the Chair, as regards:

- **Follow-up to Resolution 1709 (2010) “The functioning of democratic institutions in Albania »** : heard a report by the President on the visit of the Presidential Committee to Albania on 22 and 23 February 2010;
- **Standing Committee (Paris, 12 March 2010)**: took note of the updated draft agenda;
- **European Convention of Human Rights:**
  - i. **High-Level Conference on the Future of the European Court of Human Rights, Interlaken, 18-19 February 2010**: referred the Interlaken Declaration to the Committee on Legal Affairs and Human Rights, in order for it to draw up a report on “Effective implementation of the European Convention of Human Rights: the Interlaken process”, for presentation to the Assembly at its April 2010 part-session;
  - ii. **Consequences of the entry into force of Protocol 14 to the European Convention of Human Rights on 1 June 2010** : took note of the proposed timetable for the election of judges to the European Court of Human Rights;
- **2010 Second ordinary part-Session of the Assembly (Strasbourg, 26-30 April 2010)**: adopted the draft agenda<sup>1</sup>;
- **References and transmissions to committees**: see Appendix I;
- **Ukraine : presidential election (17 January and 7 February 2010)**: approved the report of the ad hoc Committee on the second round of this election;
- **Communications**: took note of communications by the Secretary General and the Deputy Secretary General of the Council of Europe as well as the Secretary General of the Parliamentary Assembly;
- **Reconstitution of Bureau ad hoc Committees:**
  - i. **Ad hoc Committee of the Bureau on promoting dialogue between the Georgian and Russian Assembly delegations**: held an exchange of views on this matter and decided to postpone its decision to a future meeting;
  - ii. **Ad Hoc Committee on the implementation of Resolution 1416 (2005) on the conflict over the Nagorno-Karabakh region dealt with by the OSCE Minsk Conference**: held an exchange of views on this matter and decided to postpone its decision to a future meeting;
  - iii. **Ad hoc Committee on the Forum for the future of Democracy**: decided to reconstitute this ad hoc committee and to appoint Mr David Harutyunyan (Armenia, EDG) as its chairperson for 2010, in his capacity as Chairperson of the parliamentary delegation of the host country of the Forum which would take place in Armenia;

- **Follow-up to Resolution 1583 (2007) "Improving the participation of members in Assembly plenary sessions and committee meetings"**: agreed to return to this matter following further consultation with Chairpersons of national parliamentary delegations;
- **Joint Conference of the Inter-Parliamentary Assembly of the Commonwealth of Independent States (IPA-CIS) and the Parliamentary Assembly of the Council of Europe (St. Petersburg, 8 April 2010)**: authorised the Sub-committee on conflict prevention through dialogue and reconciliation of the Political Affairs Committee to participate in this conference (in addition to the Sub-Committee on External Relations);
- **Resolution 1376 (2004) relating to Cyprus**: took note of letters from the two Turkish Cypriot political parties informing the President of the Assembly of the names of the "elected representatives of the Turkish Cypriot community" entitled to sit in the Assembly, namely Mr Ahmet Eti (National Unity Party) and Mr Mehmet Caglar (Republican Turkish Party), to be submitted to the Assembly for its approval within the framework of the Progress Report;
- **Composition of the Monitoring Committee**: approved the proposed modification to the list of members;
- **Meetings elsewhere than in Strasbourg and Paris**: authorised the Committee on Migration, Refugees and Population to meet in Brussels (Belgium) on 18 May 2010;
- **Appointment of Assembly representatives for official activities**: see Appendix II;
- **Parliamentary assistance programmes**: took note of activities carried out in 2008-2009 and plans for activities in 2010;
- **Date and place of the next meetings**: decided to hold the following meetings:
  - . Monday 26 April 2010, Strasbourg, at 8 am;
  - . Friday 30 April 2010, Strasbourg, at 8.30 am.
  - . Thursday 20 May 2010, Skopje ("The former Yugoslav Republic of Macedonia")
