Synopsis of the meeting held in Strasbourg on 26, 27, 28 and 29 January 2015

The Committee on Culture, Science, Education and Media, meeting in Strasbourg with Lady Diana Eccles (United Kingdom, EC), senior member present, and then Ms Adele Gambaro (Italy, ALDE) and Mr Piotr Wach (Poland, EPP/CD) in the Chair,

- on Monday 26 January 2015 from 2 p.m. to 3 p.m.: held a joint hearing with the Committee on Political Affairs and Democracy on "Terrorist attacks in Paris: together for a democratic response" with the participation of:
 - Ms Caroline Fourest, journalist, Paris,
 - Mr Driss Ajbali, sociologist, Paris;
- on Tuesday 27 January 2015 from 8.30 a.m. to 9.30 a.m., as regards:
- Composition of the Bureau of the committee:
 - elected Ms Adele Gambaro (Italy, ALDE) Chairperson by acclamation,
 - re-elected Mr Piotr Wach (Poland, EPP/CD) 1st Vice-Chairperson by acclamation,

- Election of the General Rapporteur on Science and Technology Impact Assessment: re-elected by acclamation Mr Jean-Yves Le Déaut (France, SOC) as 2015 General Rapporteur on Science and Technology Impact Assessment and heard his declaration of absence of conflict of interest;

- Increasing transparency of media ownership (Rapporteur: Ms Gülsün Bilgehan, Turkey, SOC): unanimously adopted a draft resolution and a draft recommendation and unanimously approved a report;
- Coordinated strategies for effective Internet governance (Rapporteur: Mr Robert Shlegel, Russian Federation, NR): considered elements for a draft report and decided to change the title of the report to "Coordination for efficient Internet governance";
- **Sport for all: a bridge to equality, integration and social inclusion** (Rapporteur: Ms Carmen Quintanilla, Spain, EPP/CD): took note of an outline report and held an exchange of views with Mr Stanislas Frossard, Executive Secretary of the Enlarged Partial Agreement on Sport (EPAS), Council of Europe;
- **Media responsibility and media ethics in a changing media environment** (Rapporteur: Mr Volodymyr Ariev, Ukraine, EPP/CD): considered a background report and held an exchange of views with Dr Rachel Craufurd Smith, Faculty of Law, University of Edinburgh;
- **Rethinking the anti-doping strategy** (Rapporteur: Mr André Schneider, France, EPP/CD): in the absence of the rapporteur, took note of an outline report and held an exchange of views with Mr Stanislas Frossard, Executive Secretary of the Enlarged Partial Agreement on Sport (EPAS), Council of Europe;
