Secretariat of the Parliamentary Assembly Synopsis No 2002/093 5 September 2002

The Committee on Legal Affairs and Human Rights, meeting in Paris on 2 September 2002 with Mr Lintner (Germany, EPP/CD) in the Chair, as regards:

- Danger of bilateral immunity agreements for the International Criminal Court: decided to make a request for an urgent debate on this matter and appointed Mr Marty (Switzerland, LDR) Rapporteur, should the Bureau accede to this request;
- Legal situation of Roma in Europe: decided to declassify the minutes of the hearing held on 4 March 2002 in Paris;
- Preferential treatment of national minorities by their kin-state: the case of the Hungarian Status Law of 19 June 2001 (Rapporteur: Mr Jurgens, Netherlands, SOC): held an exchange of views and decided to consider a new revised draft report at a forthcoming meeting;
- Protection of minorities in Belgium (Rapporteur: Mrs Nabholz-Haidegger, Switzerland, LDR): considered and adopted a draft resolution and a draft order submitted by the Rapporteur;
 - Implementation by Turkey of decisions of the European Court of Human Rights (Rapporteur: Mr Jurgens, Netherlands, SOC): considered and adopted a draft resolution and considered, amended and adopted a draft recommendation submitted by the Rapporteur;
- Draft additional Protocol to the Convention on Cybercrime concerning the criminalisation of acts of a racist and xenophobic nature committed through computer systems: appointed Mr Guardans (Spain, LDR) as its Rapporteur, and considered, amended and adopted a draft opinion submitted by the Rapporteur;
- Racism, xenophobia and intolerance: the rise of far right-wing political parties in Europe (Rapporteur: Mr McNamara, United Kingdom, SOC): considered an introductory memorandum submitted by the Rapporteur and considered changing the title of the report;
- Situation in Belarus: decided to postpone the appointment of a rapporteur for opinion to replace Mr Svoboda, and decided to set up a sub-committee to clarify the circumstances of disappearances for allegedly political reasons in Belarus composed as follows: Mr Akçali (Turkey, EDG), Mr Cilevičs (Latvia, SOC), Mr Clerfayt (Belgium, LDR), Mr de Aristegui (Spain, EPP/CD), Mr Kovalev (Russia, LDR), Mr Lippelt (Germany, LDR), Mr McNamara (United Kingdom, SOC), Mr Pourgourides (Cyprus, EPP/CD), Mr Shybko (Ukraine, SOC) et Mr Stankevič (Lithuania, LDR);
- Federal Republic of Yugoslavia's request for membership of the Council of Europe (Rapporteur for opinion: Mr Lippelt, Germany, LDR): heard a statement by the Rapporteur, and was informed by Mr Prica (special guest, FRY) about the political situation in FRY, and particularly in Serbia;

- Sub-Committee on Human Rights: took note that Mr Demetriou (Cyprus, EPP/CD) had been replaced by Mr Pourgourides (Cyprus, EPP/CD) as a member;
- Parliamentary Conference on the Stability Pact (Tirana, 14-16 October 2002): decided to be represented at the Conference by its Sub-Committee on Penal Law and Criminology;
