**The Committee on Migration, Refugees and Displaced Persons**, meeting in Strasbourg, on 24, 25 and 26 April 2012 with Mr Giacomo Santini (Italy, EPP/CD) in the Chair,

    - ***The situation in Syria:*** in view of the urgent debate, appointed **Mr Giacomo Santini** (Italy, EPP/CD) Rapporteur for opinion and heard from him a statement concerning the absence of any conflict of interest;
    - ***Lives lost in the Mediterranean Sea: who is responsible?*** (Rapporteur: Ms Tineke Strik, Netherlands, SOC): took position on the amendments to the draft resolution and held an exchange of views with **Father Mussie ZERAI**, Priest;
