



## FOR THE ATTENTION OF MEMBERS OF THE COMMITTEE ON THE HONOURING OF OBLIGATIONS AND COMMITMENTS BY MEMBER STATES

Secretariat of the Assembly Synopsis N° 2002/037 4 April 2002

The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe, meeting in Paris on 3 April 2002 with Mr Bársony in the Chair:

- Functioning of democratic institutions in Moldova (co-rapporteurs: Mrs Durrieu, France, SOC, and Mr Vahtre, Estonia, EPP/CD): considered a draft report, authorised the co-rapporteurs to carry out a fact-finding visit to Chisinau on 8 and 9 April 2002 and asked the co-rapporteurs to present a revised draft report to the next meeting, including a draft resolution and draft recommendation;
- Ukraine (co-rapporteurs: Mrs Severinsen, Denmark, LDR and Mrs Wohlwend, Liechtenstein, EPP/CD): in the absence of the co-rapporteurs, held an exchange of views on the parliamentary elections held on 31 March 2002;
- Activities of the Monitoring Committee: considered a memorandum presented by the Chair and decided to continue the discussion at a future meeting on the basis of a revised memorandum;
- Post-monitoring dialogue with "the former Yugoslav Republic of Macedonia": decided to postpone to a future meeting consideration of the memorandum presented by the Chair, which was revised after his fact-finding visit to the country from 27 February to 1 March 2002;
- Post-monitoring dialogue with Romania: heard a short presentation of the contribution by the Romanian delegation and decided to continue its consideration at the meeting on 15-17 May 2002;
