The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee), meeting in Strasbourg, on 23, 24, 25 and 26 January 2012, with first Ms Josette Durrieu (France, SOC), the oldest member present, and then Mr Andres Herkel (Estonia, EPP/CD) in the Chair:

as regards:

- Composition of the Committee's Bureau¹:
 - . elected Mr Andres Herkel (Estonia, EPP/CD) Chairperson
 - . elected Ms Lise Christoffersen (Norway, SOC) Vice-Chairperson
 - . elected Mr Telmo Correia (Portugal, EDG) Vice-Chairperson
 - . elected Mr Pieter Omtzigt (The Netherlands, EPP/CD) Vice-Chairperson
- Bosnia and Herzegovina (co-rapporteurs: Ms Karin S. Woldseth, Norway, EDG, and ...): heard a statement by Ms Woldseth on the latest developments, approved three amendments tabled on behalf of the committee, and took position on the amendments to the draft resolution on the functioning of democratic institutions in Bosnia and Herzegovina;
- Russian Federation (co-rapporteurs: Mr György Frunda, Romania, EPP/CD, and Mr Andreas Gross, Switzerland, SOC): heard an oral report on the post-electoral mission to Moscow (20-21 January 2012);
- Georgia (co-rapporteurs: Mr Kastriot Islami, Albania, SOC, and Mr Michael Aastrup Jensen, Denmark, ALDE): declassified a revised information note by the co-rapporteurs on their fact-finding visit to Tbilisi and Batumi (11-14 October 2011);
- Council for Democratic Elections (Venice Commission): appointed, for the year 2012, Ms Karin S.
 Woldseth (Norway, EDG) as representative and Ms Marietta de Pourbaix-Lundin (Sweden, EPP/CD) as substitute of the Committee to the Council for Democratic Elections:

- Montenegro (co-rapporteurs: Mr Jean-Charles Gardetto, Monaco, EPP/CD, and ...): considered a
 preliminary draft report on the honouring of obligations and commitments by Montenegro and decided to
 transmit it to the authorities of Montenegro for comments;
- Armenia (co-rapporteurs: Mr Axel Fischer, Germany, EPP/CD, and Mr John Prescott, United Kingdom, SOC): decided to consider this issue at a forthcoming next meeting;
- Serbia (co-rapporteurs: Mr Davit Harutyunyan, Armenia, EDG, and Mr Indrek Saar, Estonia, SOC): took position on the amendments to the draft resolution on the honouring of obligations and commitments by Serbia;
- Hungary: motion to open a monitoring procedure (co-rapporteurs: Ms Jana Fischerová, Czech Republic, EDG, and Ms Kerstin Lundgren, Sweden, ALDE): heard oral information from the co-rapporteurs on the latest developments, approved a statement of the Committee prepared by the co-rapporteurs and decided to ask the Venice Commission for an opinion on five laws adopted by the Hungarian Parliament;
- Republic of Moldova (co-rapporteurs: Ms Lise Christoffersen, Norway, SOC, and Mr Piotr Wach,
 Poland, EPP/CD): heard an oral report on the fact-finding visit to Chisinau (28 November 1 December 2011) and decided to come back to this issue at its next meeting;
- Bulgaria (rapporteur: Mr Luca Volontè, Italy, EPP/CD): heard an oral report on the fact-finding visit to Sofia (20-21 December 2011);
- Ukraine (co-rapporteurs: Ms Mailis Reps, Estonia, ALDE, and Ms Marietta de Pourbaix-Lundin, Sweden, EPP/CD): took position on the amendments to the draft resolution on the functioning of democratic institutions in Ukraine and decided to ask the Venice Commission for an opinion on the draft law on prosecution prepared by the Ukrainian Committee for the strengthening of the rule of law;
- Authorisation of fact-finding visits: authorised fact-finding visits to Albania, Bosnia and Herzegovina, Bulgaria and Ukraine;
- Next meeting: decided to hold its next meeting in Paris on 13 March 2012.
