The Political Affairs Committee, meeting in Strasbourg on 27 to 30 January 2003 under the chairmanship of first Mr Wielowieyski (Poland, EPP), oldest member present, and then Mr Jakič (Slovenia, LDR),

Re-elected by acclamation:

Mr Jakič (Slovenia, LDR) Chairman,
Mr Rogozin (Russia, EDG) First Vice-Chair,
Mrs Feric-Vač (Croatia, SOC) Second Vice-Chair,
Mr Spindelegger (Austria, EPP) Third Vice-Chair;

As regards:

- *The request for a debate on Iraq under urgent procedure:* appointed Mr Martínez-Casañ (Spain, EPP) rapporteur, adopted a draft Resolution and prepared the urgent debate in the Assembly on 30 January by examining the amendments which had been submitted;
- *Conflict in the Chechen Republic (Rapporteur: Lord Judd, United Kingdom, SOC):* heard a report by the Rapporteur on his visit to Moscow and the North Caucasus (19 - 24 January 2003), adopted a draft Resolution, a draft Recommendation and a draft Order, took position on the amendments which had been presented, held an exchange of views on the debate in the Assembly, and took note of the declaration by the Rapporteur about his intention to resign if the referendum in the Chechen Republic was not postponed;
- *Contribution of the Council of Europe to the constitution-making process of the European Union (Rapporteur: Mr Pangalos, Greece, SOC):* took position on the amendments submitted on the draft Resolution;
- *Code of good practice in electoral matters:* confirmed the appointment of Mr Clerfayt (Belgium, LDR) as Rapporteur for the urgent procedure debate, took position on the amendments submitted;

- *Amendments to the Constitution of Liechtenstein proposed by the Princely House of Liechtenstein*: took note that the Assembly did not agree with the proposal of the Bureau to hold a debate under urgent procedure on this subject, and asked Lord Kilclooney (United Kingdom, EPP) to make his opinion on this subject known to the members of the Committee in the form of a memorandum:

- *Appointment of rapporteurs*: appointed the following rapporteurs:
 - *Request for Council of Europe membership: Principality of Monaco*: Mr Slutsky (Russia, SOC);
 - *Presence of the Council of Europe in Northern Ireland*: Mr Ouzky (Czech Republic, EDG)
 - *Situation in Belarus*: Mr Goris (Belgium, LDR);
 - *New methodological concepts of democracy to evaluate its implementation*: Mr Severin (Romania, SOC);
 - *Western Sahara*: Mr Puche (Spain, EPP)
 - *Relations between Europe and the United States*: Mr Azzolini (Italy, EPP)

- *Nomination of representatives*:
 - *Joint Round Table between 'ECRI and the EUMC on Community Cohesion (Strasbourg, 21 March 2003)*: nominated Mrs Feric-Vač (Croatia, SOC), and decided to discuss, at a future meeting, the opportunity to create an ad hoc sub-committee to participate at the Round Table;

- *Sub-Committees*: reconstituted its sub-committees, and asked the French, Italian and Russian delegations to present only candidate per sub-committee and decided to define the final composition of its sub-committees at its next meeting.

- *Dates and places of its next meetings*:
 - Paris, 5 March 2003;
 - Strasbourg, 31 March - 4 April 2003 (2nd part-session 2003);
 - Berlin (Germany), 29 April 2003, on the occasion of the meeting of the Standing Committee;
 - Sarajevo (Bosnia and Herzegovina), 19 - 20 May 2003, on the occasion of a colloquy co-organised with the Parliament of Bosnia and Herzegovina (*Subject to the Bureau's authorisation*);
 - Athens (Greece), 9 - 10 June 2003;
 - Strasbourg, 23 - 27 June 2003 (3rd part-session 2003).
