**The Political Affairs Committee**, meeting in Athens on 9 and 10 June 2003 with Mr Roman Jakič (Slovenia, LDR) in the Chair,

- held on 9 June, in co-operation with the Greek Parliament, a colloquy on the "Political impact of migration flows", with the participation of:

## as regards:

- Threat posed to democracy by extremist parties and movements in Europe (Rapporteur: Mrs Feric-Vać, Croatia, SOC): held an exchange of views based on a preliminary draft report presented by the Rapporteur;
- Future of democracy (Rapporteur: Mr Wielowieyski, Poland, EPP): held an exchange of views based on a preliminary draft report presented by the Rapporteur, asked the Rapporteur to draft a revised version which should be examined at the meeting on 11 September 2003, and asked its Chairman to make a request to the Bureau to extend the validity of the reference;
- Request for Council of Europe membership: Principality of Monaco (Rapporteur: Mr Slutsky, Russia, SOC): heard an oral statement by the Rapporteur on his visit to the Principality of Monaco (2 3June 2003), and took note that the Rapporteur would present a memorandum on this subject at the next meeting of the Committee;
- Conflict dealt with by the Minsk Conference of the OSCE (Rapporteur: Rt. Hon. Terry Davis, United Kingdom, SOC): authorised the Rapporteur to go to The Hague to meet the Co-Chairs of the Minsk Group and the personal representative of the Chairman-in-Office of the OSCE (on 11 June 2003), and to visit the region again at an appropriate time;
- Council of Europe presence in Northern Ireland (Rapporteur: Mr Ouzky, Czech Republic EDG): heard an oral statement by the Rapporteur, authorised him to carry out a visit to the United Kingdom (including Northern Ireland) and the Republic of Ireland, and asked its Chairman to make a request to the Bureau to extend the validity of the reference;
- was informed that the President of the Assembly intends to meet the chairpersons of the committees during the next part-session of the Assembly, and asked its Chairman to keep the Committee informed:
- asked its Chairman to write to the Bureau to express the Committee's wish to present opinions to the debates on *The situation of Palestinian refugees* and on *Political prisoners in Azerbaijan* during the next part-session of the Assembly;
- heard a statement by the Rt. Hon. Terry Davis (United Kingdom, SOC) and by Mr Severin (Romania, SOC) on the 4<sup>th</sup> Stability Pact Parliamentarian Conference on "A new European Union Policy for South Eastern Europe, a Renewed Stabilisation and Association Process and the Perspective for Accession", organised by the European Parliament (Brussels, 21 22 May 2003);
- took note of an invitation by the Chairman of the delegation of Turkey to hold a meeting of the Committee and, possibly, a colloquy in May 2004 in Turkey;
- Nomination of rapporteurs
  - Convention on the future of Europe and the Council of Europe: Mr Pangalos (Greece, SOC), subject to the decision of the Assembly to hold a debate under urgent procedure;
  - o Situation in Kazakhstan: Mr Iwinski (Poland, SOC);
  - Decided that, henceforth, whenever there is more than one candidate for a report, the Committee would proceed to the nomination after having heard a statement by the candidates;
