The Political Affairs Committee, meeting in Strasbourg from 4 to 7 October 2010, with Mr Lipiński (Poland, EPP/CD) and then Mr von Sydow (Sweden, SOC) in the Chair:

as regards:

- Debate under urgent procedure on "Recent rise of national security discourse in Europe: the case of Roma": appointed Mrs Brasseur (Luxembourg, ALDE) as Rapporteur, considered and approved a report and unanimously adopted a draft resolution, and subsequently took position on the amendments tabled;

- **Promoting parliamentary diplomacy** (*Rapporteur: Mr Mota Amaral, Portugal, EPP/CD*): considered and approved a report and unanimously adopted a draft resolution;

- **Fight against extremism: achievements, deficiencies and failures** (*Rapporteur: Mr Agramunt, Spain, EPP/CD*): took position on the amendments tabled to the draft resolution and to the draft recommendation;

- **Measures to improve the democratic character of elections in the Council of Europe member states** (*Rapporteur: Mr Gardetto, Monaco, EPP/CD*): heard a statement by the Rapporteur on the basis of an outline for a report;

- **Situation in Belarus** (*Rapporteur: Mrs Hurskainen, Finland, SOC*): heard a statement by the Rapporteur and held an exchange of views with the participation of Mr Thomas Markert, Secretary of the Venice Commission, Mr Nikolai Samoseiko, Chairman of the Standing Committee on Legislation and Judicial and Legal Matters of the House of Representatives of Belarus and Head of the parliamentary *ad hoc* group on capital punishment matters, and Mr Aleh Hulak, Chairman of the "Belarusian Helsinki Group";

- Follow-up to the reform of the Council of Europe (*Rapporteur: Mr Mignon, France, EPP/CD*): heard a statement by the Rapporteur, decided to invite the Secretary General of the Council of Europe for an exchange of views on the process of reform at its forthcoming meeting (Paris, 18-19 November 2010), and took note of the reply by the Committee of Ministers to Recommendation 1886 (2009) on *The future of the Council of Europe in the light of its sixty years of experience*;

- Request from the Parliament of Morocco for partner for democracy status within the Parliamentary Assembly (*Rapporteur: Mr Volontè, Italy, EPP/CD*): heard a statement by the Rapporteur, held an exchange of views with Mrs Lyadi, Deputy to the House of Representatives of the Parliament of Morocco, endorsed the request by Mr Volontè to carry out a fact-finding visit to Morocco, in the forthcoming months, and accordingly asked its Chairman to request to the authorisation of the Bureau;

. Recommendation 1871 (2009) Ban of cluster munitions;

. Broadening the Parliamentary Assembly activities: scrutinising of Council of Europe's activities

c) authorised Mr Lipiński to carry-out a fact-finding visit to Kiyv (Ukraine) in the framework of the preparation of his report on *The Council of Europe and the Eastern partnership of the European Union*.

- **Preparation for the participation in the 65th General Assembly of the United Nations**: heard a statement by its Chair and held an exchange of views:

. took note of the draft resolution of the General Assembly of the United Nations on co-operation between the United Nations and the Council of Europe approved by the Committee of Ministers;

. was informed that the UN General Assembly would hold a debate on co-operation between the United Nations and the Council of Europe on 13 December 2010, while the Political Affairs Committee would meet in Paris on 14-15 December 2010;

. decided (subject to the authorisation by the Bureau) to hold a meeting in New York during the IPU Parliamentary meeting on the occasion of the 65th General Assembly of the United Nations (2-3 December 2010), and to set up a separate programme of meetings with UN representatives focused on domains of interest for the Assembly;

. took note that its Chair would leave the Assembly in November 2010 and thanked him for his contribution to the work of the Sub-Committee.
