## **Synopsis**

23 June 2011

The Committee on Rules of Procedure, Immunities and Institutional Affairs, meeting in Strasbourg on 21 June 2011 with Mr Vareikis (Lithuania, EPP/CD) in the Chair, as regards:

- Ensuring protection against attacks on the honour and reputation of persons (rapporteur: Mrs Bemelmans-Videc, the Netherlands, EPP/CD): considered and approved a report, adopted with one abstention a draft resolution and asked its Chairperson to present them at the next meeting of the Standing Committee (Edinburgh, 25 November 2011);
- Freedom of access and movement for Parliamentary Assembly members in Council of Europe member states: following an opinion addressed by the committee to the Bureau of the Assembly on 6 October 2010 and following the decision of the Bureau, asking the committee to make proposals for concrete actions, the committee asked its Chairperson to inform the Bureau that not any new proposal having been made, it renewed his preceding recommendations;
- Appointment of rapporteurs (subject to a reference by the Assembly on 24 June):
  - . Amendment of various provisions of the Assembly's Rules of Procedure implementation of Resolution 1822 (2011): Mr Gross (Switzerland, SOC)
  - . Terms of reference of Assembly committees implementation of Resolution 1822 (2011): Mr Vareikis (Lithuania, EPP/CD);
