Secretariat of the Parliamentary Assembly Synopsis N° 2011 / 02 25 March 2011

The Social, Health and Family Affairs Committee, meeting in Paris on Tuesday, 22 March 2011, with Ms Maury Pasquier (Switzerland, SOC), in the Chair:

As regards:

- Safeguarding children and young people from obesity and type 2 diabetes (Rapporteur: Mr Hancock, United Kingdom, ALDE): approved the new title of the report, as indicated above, considered a draft report, amended and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report to the Assembly at the April part-session;
- Combating poverty (Rapporteur: Mr Volontè, Italy, EPP/CD): considered a draft report, amended and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report to the Assembly at the April part-session;
- Over-indebtedness of States: a danger for democracy and human rights (Rapporteur: Mr Hunko, Germany, UEL): considered a preliminary draft opinion and decided to come back to the issue at its meeting on 11 April in Strasbourg;
- Council of Europe campaign to stop sexual violence against children: heard a statement by the Chairperson, and decided to hold the 2nd meeting of the contact parliamentarians on 13 April 2011 in Strasbourg, and a Sub-Committee on Children meeting open to contact parliamentarians in Kyiv, Ukraine, on 24-25 May 2011 on the occasion of the International conference organised in the framework of the Ukrainian Chairmanship of the Council of Europe Committee of Ministers on "Combating violence against children: from isolated actions to integrated strategies" (subject to authorisation by the Bureau);
- Committee's work programme:
 - ✓ appointed Ms Maury Pasquier (Switzerland, SOC) rapporteur for report on "Putting an end to coercive sterilisations and castrations";
 - ✓ appointed Ms Ohlsson (Sweden, SOC) rapporteur for report on "The role of parliaments in the consolidation and development of social rights in Europe";

- ✓ appointed Mr Barbi (Italy, ALDE) rapporteur for report on "Unfair economic competition by third countries: social dumping";
- decided to postpone the appointment of a rapporteur on "Towards a Council of Europe Convention to combat trafficking in organs, tissues and cells of human origin" to its meeting at the April partsession:
- ✓ appointed Mr Flynn (United Kingdom, SOC) rapporteur for opinion on "Nanotechnologies, a new danger to the environment";
- ✓ and heard declarations on the absence of any conflict of interest by the Rapporteurs, who were
 given copies of the code of conduct;
- heard a statement by Ms Ohlsson (Sweden, SOC) who took part in the 1st seminar on the Reform of the European Social Charter, Helsinki, 8 February 2011 and by Mr Flynn (United Kingdom, SOC) who took part in the Workshop on "H1N1 influenza pandemic: Which lessons to learn for a better EU Management and EU coordination with Member States?", European Parliament, Brussels, 9 February 2011;
- considered the replies of the Committee of Ministers to the Recommendations on:
 - "Children who witness domestic violence"
 - "The handling of the H1N1 pandemic: more transparency needed"

and instructed the Chairperson to write a letter to the Bureau on the latter reply, considered unsatisfactory by the Committee;

- Combating child pornography as part of the campaign to stop sexual violence against children (working title): organised a hearing and held an exchange of views with the participation of:
 - Mr Conde Bajén (Spain, EPP/CD), rapporteur
 - Mr Arturo Canalda, Ombudsman for Children of the Community of Madrid
 - Ms Cristiana De Paoli, Save the Children Italia, Head of Unit for Children and New Media
 - Mr Frédéric Malon, Chief superintendent, Head of the OCRPV (Central Office for the Prevention of Violence against Individuals), Central Directorate of the Criminal Investigation Department, France

Resuming its meeting on Wednesday, 23 March 2011, with Ms Maury Pasquier (Switzerland, SOC) in the Chair:

- Health hazards of heavy metals (Rapporteur: Mr Huss, Luxembourg, SOC): considered a revised introductory memorandum;
- Decent pensions for all in the wake of the economic and financial crisis (Rapporteur: Mr Jacquat, France, EPP/CD): approved the new title of the report, as indicated above, considered an outline report, and prepared a hearing to be held during the April 2011 part-session of the Assembly (Thursday, 14 April 2011, at 8.30 am);
- Unaccompanied children in Europe: issues of arrival, stay and return (Rapporteur: Ms Coleiro Preca, Malta, SOC): considered and approved a draft opinion including six amendments to the report tabled by the Committee on Migration, Refugees and Population;
- Reform of the Parliamentary Assembly: heard a statement by the Chairperson, held an exchange of views and prepared the Committee's opinion with a view to adopting it during the April part-session;
- Changes in the composition of sub-committees: approved the following changes: Mr Van der Maelen (Belgium, SOC) as new alternate of the Sub-Committee on Children, Mr Vercamer (Belgium, EPP/CD) as new member of the Sub-Committee on the European Social Charter and Employment, Mr Hancock (United-Kingdom, ALDE) as member of the Sub-Committee on Children;
- What can Europe do for children in the aftermath of natural disasters and crisis situations: the example of Haiti: held an exchange of views with the participation of:
 - Ms Hostalier (France, EPP/CD), rapporteur
 - Mr Michel Forst, UN Special Rapporteur on the situation of Human Rights in Haiti
 - Ms Isabelle Moussard-Carlsen, Desk Officer in charge of the mission in Haiti, Action contre la faim (Action Against Hunger)

- Mr Pierre Salignon, Director General for Humanitarian Action, Médecins du Monde France (Doctors of the World)
- Mr Pierre Poupard, Senior Emergency Coordinator, UNICEF headquarters
- Forum for the Future of Democracy: decided to appoint five members to the Ad Hoc Committee of the Bureau at its next meeting during the April 2011 part-session, and suggested that one of these members act as General Rapporteur for the Forum in view of the subject-matter;
- Date and place of the next meetings: decided to hold its next meetings as follows:
