Synopsis of the meeting held in Paris on 15 March 2016

The Committee on Social Affairs, Health and Sustainable Development, meeting in Paris on 15 March 2016, with Ms Stella Kyriakides (Cyprus, EPP/CD), Chairperson, in the Chair, as regards:

- **Human rights and ethical issues related to surrogacy** (*Rapporteur: Ms Petra De Sutter, Belgium, SOC*): considered a revised draft report *in camera* and rejected the amended preliminary draft resolution and the amended preliminary draft recommendation; the Chairperson informed the Committee that it remained seized on the issue and that she would thus put the item on the agenda of the Committee meeting during the April 2016 part-session of the Assembly;
- **Election of the 2nd Vice-Chairperson of the Committee**: pending the UEL Group's formal proposal on the candidate to be put forward, postponed this item to its next meeting;
- **Effectively combating the adverse consequences of dirty money** (*Rapporteur: Mr Stefan Schennach, Austria, SOC*): held an exchange of views with Mr John Ringguth (United Kingdom), financial expert and former Executive Secretary of MONEYVAL (Committee of Experts on the Evaluation of Anti-Money Laundering Measures and the Financing of Terrorism) and Mr Luc Recordon, Lawyer and Director at the Vaud Cantonal Bank (Switzerland);
- **Preventing the radicalisation of children by fighting the root causes** (*Rapporteur: Ms Sevinj Fataliyeva, Azerbaijan, EC*): considered a draft report and unanimously adopted a draft resolution as it stands with a view to the report being debated during the April 2016 part-session of the Assembly, noting the intention of the Rapporteur to table an addendum to the report and a number of amendments for consideration by the Committee at its first meeting during the April part-session with a view to taking into account comments made by members;
- **Involuntary placement and treatment of people with psychosocial disability: need for a new paradigm**: (*Rapporteur: Ms Guguli Magradze, Georgia, SOC*): considered a draft report, decided to change the title of the report to "The case against a Council of Europe legal instrument on involuntary measures in psychiatry", and unanimously adopted a draft recommendation with a view to the report being debated during the April 2016 part-session of the Assembly;
- **The handling of international public health emergencies** (*Rapporteur: Ms Sílvia Eloïsa Bonet, Andorra, SOC*): considered a draft report and unanimously adopted a draft resolution with a view to the report being debated during the April 2016 part-session of the Assembly;
- **Follow-up to the Parliamentary conference on the MEDICRIME Convention, 24 November 2015, Paris**: heard a statement by the Chairperson;
